# DILG clarifies road clearing operations nationwide, not just in Metro Manila

The Department of the Interior and Local Government (DILG) clarified that the directive issued by the Department in line with President Rodrigo Duterte's instruction to clear roads of obstructions does not only cover local chief executives (LCEs) of Metro Manila but all Local Government Units across the entire country.

"No local government is exempted from the directive. We are just giving extra attention to Metro Manila because the problem of road obstructions is most acute in the National Capital Region (NCR) but the memorandum circular covers the entire country," said DILG Undersecretary and Spokesperson Jonathan E. Malaya.

Malaya explained that since the instruction to "reclaim public roads which

On July 29, 2019, the DILG issued Memorandum Circular 2019-121 directing all governors, mayors, and punong barangays to exercise their powers essential to reclaim public roads, rid them of illegal structures and constructions, rehabilitate them by placing street names and street lights, and carry out strategies to address possible displacement issues. ment. This collaboration between the neighboring countries is crucial to rapidly respond to public health threats and prevent greater health risks including epidemics, microbial resistance, among others.

They also reaffirmed their commitment to support each other in joint activities, such as port-to-port collaboration on healthcare and vaccination programme for children in Alternative Learnings Centers, as part of efforts to help realize Universal Health Care under ASEAN.

"We both hope that the outcome of this meeting will further strengthen the ties and cooperation in the management of cross-border issues relating to the health of both our countries and across various stakeholders, and we look forward to a lasting collaboration between both countries in tackling and resolving health issues," Philippine Health Secretary Duque concluded.

mga Smoke-Free Ordinance na nagtatakda ng 100% smoke free na mga lugar na naaayon sa EO 26 habang 48 lungsod naman ang naglagay ng mga DSA sa kanilang mga lokalidad.

"Malaking bilang na ito ngunit may mga lungsod pa rin na hindi sumusunod sa mga smoke-free policy lalo na ang nabanggit sa EO 26. Ang ibig sabihin ng Smoke-free ay 100% free sa usok ng tabako, kung saan hindi na ito nakikita, naaamoy, nararamdaman o nasusukat," ani Malaya.

Samantala, 65 na mga lungsod naman ang nagbuo ng kanilang mga Smoke-Free Task Force na siyang titiyak na ang mga smoke-free policy ay nasusunod. "Ito ay maaari nating iugnay sa matibay na paninindigan ng pamahalaan na isulong ang smokefree na kapaligiran," aniya.

Partikular na pinuri ni Malaya ang Davao City, Balanga City at Iloilo City para sa pagpapalawak ng kanilang mga smokefree environment na higit pa sa hinihingi ng batas sapagkat sa mga lungsod na ito ay pinagbawal ang paninigarilyo sa lahat ng pampublikong lugar maliban sa mga DSA na tinukoy ng mga pamahalaang lokal.

Kinilala rin niya ang Taguig City at Cotabato City na sumunod sa engineering standards na itinatakda para sa mga DSA sa ilalim ng EO, pati na ang Baguio City, Marikina City at Pasig City na nagdisenyo ng komprehensibong Smoke-free Task Forces.

Mataas man ang bilang ng mga susumusunod sa batas, iminumungkahi pa din ng pag-aaral na magdeklara ng 100% smoke-free sa mga lugar na nabanggit sa EO 26, at kailangan ding nakaayon sa engineering requirements na itinatadhana ng EO ang batayan sa paggawa ng mga DSA.

"Hinihikayat ang mga lungsod na bumuo ng mga smoke-free task force upang tiyakin ang patuloy na implementasyon at pagpapairal ng EO 26 sa kani-kanilang lokalidad," dagdag niya.

Dalawang taon mula ng isinabatas ang EO 26, hinihimok ng DILG ang lahat ng pamahalaang lokal na gawing prayoridad ang pagpasa ng mga ordinansa na magtatakda ng mga 100% smoke-free na lugar "upang tiyakin na ang ating mga pamayanan ay ligtas mula sa lahat ng masamang epekto ng direkta o secondhand smoking."

"Natutuwa tayo sa pagpapamalas ng mga pamahalaang lokal at publiko ng kanilang suporta sa adbokasiyang ito at atin pong hiling na mas marami pang pamahalaang lokal ang seryoso at mabilisang tutugon sa kautusan ng Pangulo sapagkat ito ay nakatuon sa kalusugan ng ating mga mamamayan," sabi ng DILG Undersecretary.

Inisyu ng Pangulo ang EO 26 noong 2017 na nagbabawal sa paninigarilyo sa mga enclosed na pampublikong lugar at transportasyon, paaralan, at lugar pasyalan ng mga menor de edad, at nagbigay din ng mahigpit na pamantayan ukol sa mga DSA.

Ayon sa pinakahuling Pulse Asia Survey, isa sa apat na Pilipino ang naninigarilyo. Ang epekto ng paninigarilyo ay mapanganib para sa naninigarilyo, at sa mga tao at pamayanan na nakapaligid sa kanila sa pamamagitan ng second-hand smoking.

Simula 2017, pinaigting ng Kagawaran ang mga polisiya at hakbang laban sa paninigarilyo at ang pagbili at pag-advertise ng mga produktong tabako. ## POLICE AND CHURCH BAT FOR LOCALIZED PEACETALKS TO END INSURGENCY

In the meeting, the highest leader of the Roman Catholic faith in the Philippines suggested the formation of an "Ecumenical Fellowship" among the various religious congregations in the country similar to what he initiated during his diocesan work in Cavite.

For his part, Albayalde expressed agreement with the prelate that "any call for peace talks must come from the broad sector of society and not just a unilateral declaration from either government or underground movement."



The PNP is actively pursuing national government efforts to End Local Communist Armed Conflict (ELCAC) thru a multi-sectoral undertaking.

During the same meeting Albayalde voice-out concern over infiltration of some church organizations by the communist terrorist groups.


