The Department of Budget and Management has approved next year's budgetary requirement of the Department of Social Welfare and Development (DSWD) for the scaled up implementation of "Walang Gutom 2027," a flagship program of the Marcos administration.

₱6-B halaga ng iligal na droga, winasak ng PDEA

TRECE MARTIRES CITY, Cavite (PIA) — Aabot sa mahigit ₱6 bilyong halaga ng iba't ibang klase ng iligal na droga ang winasak ng Philippine Drug Enforcement Agency nitong Biyenes, Oktubre 20, sa Integrated Waste Management Incorporated Barangay Aguado, Trece Martires City sa pamamagitan ng thermal decomposition o thermolysis.

Ang iligal na droga na nagkakahalaga ng ₱5,968,744,462.01 ay nakumpiska ng PDEA sa magkakahiwalay na operasyon nito sa iba't ibang bahagi ng bansa. Kabilang sa mga ito ang 274 kilograms ng methamphetamine hydrochloride o shabu na nakumpiska sa Manila International Container Port (MICP) noong Oktubre 6, 2023; 208 kilograms ng dimethyl sulfone na na-rekober naman ng National Bureau of Investigation noong Agosto 25, 2023.

Sa kabuuan, aabot sa 1,019,204.7581 gramo ng iligal na droga ang winasak ng PDEA kasama ang 471,478 gramo ng shabu, 312.993 gramo ng marijuana,

No increase in Covid-19 cases in PH — DOH chief

MANILA - The Department of Health (DOH) on Tuesday said the country has not recorded an increase in cases of coronavirus disease 2019 (Covid-19).

This, after Singapore recorded 2,000 daily cases of Covid-19 in the past two weeks due to EG.5 and HK.3 subvariants which are considered descendants of Omicron XBB.

"We don't have an increase in Covid cases. Singapore has reported another variety of

Omicron but it's still mild and there are no deaths reported," DOH Secretary Teodoro Herbosa told reporters in a Palace briefing.

He said the DOH Epidemiology Bureau is monitoring Covid-19 infections and the public would be informed for any significant rise in cases.

In its latest case bulletin, the DOH reported that the country's daily average for new Covid-19 cases de-
