# PH, Japan to hold joint research on water concerns

MANILA – Researchers from Japan and the Philippines will work together in finding solutions to address water concerns such as lack of potable water in far-flung areas, an official of the Department of Science and Technology (DOST) said Tuesday.

"There are many issues that our local and international experts would like to address. These include the lack of potable water in far-flung communities here and in Japan," DOST Undersecretary Leah Buendia told the Philippine News Agency.

Representatives from the DOST and their counterpart from the Japan Science and Technology (JST) Agency recently met to discuss joint research works.

Buendia said one of the solutions that could be done locally is water treatment through a membrane process.

A researcher from Japan has shared that moringa seed could be used as coagulant in the pretreatment of seawater, she said. Moringa seed is locally available, making it accessible for the communities in the Philippines.

The JST has allocated JPY24 million while the DOST has allotted PHP10 million for their researchers, for joint research projects that should be finished not later than three years.

Among the concepts they would work on are solutions to water security and shortage, advanced technology for innovative water desalination, sustainable management and optimization of water resources, and water resilience.

Buendia said both countries would open a call for proposals on June 17. They will apply the same time frame and guidelines.

"They must be able to talk to their counterparts prior to

## CSC chief to gov't workers: Honor Philippine Flag

MANILA, (PIA) -- The head of the Civil Service Commission (CSC) called on government officials and employees nationwide Friday to manifest patriotism by properly honoring the Philippine flag during the annual National Flag Days from May 28 to June 12.

In a memorandum circular, CSC Chairperson Karlo Nograles reminded state workers that the nearly two-week flag commemoration provides "an opportune time for all Filipinos to collectively reflect on the significance of our National Flag."

"The Philippine flag is more than a symbol of independence. It represents the collective pursuit of Filipinos for freedom and national progress," Nograles said. "As civil servants, let us lead by example in demonstrating our patriotism not only through words but through actions, starting with the simple act of respecting the flag."

The CSC chief cited Republic Act 8491, the Flag and Heraldic Code, which mandates that "reverence and respect shall at all times be accorded the flag, the anthem and other national symbols."

Under the law, all government offices must conduct flag-raising ceremonies every Monday morning and retreats on Friday afternoons. It prohibits mutilating, trampling or casting dishonor on the Philippine colors.

Improper display or use of the flag for advertising, merchandise, costumes or uniform is also not allowed.

Nograles reminded officials and employees to abide by the "nationalism and patriotism" norm under the Code of Conduct for Public Sector Workers.

The National Flag Days commemorates the first unfurling of the Philippine flag on May 28, 1898, after revolutionary forces defeated Spanish troops in the Battle of Alapan in Cavite province, south of Manila. (PIA-NCR)

"We need prayer for the preservation of the family so that divorce does not happen in the Philippines," Mayugba said. "We need to pray for peace, love, and joy in the family."

A divorce bill moved closer to becoming a law after the House of Representatives approved it on third and final reading last week.

The Philippines is the

only place outside the Vatican where divorce is outlawed.

The bishop emphasized that prayer is our best weapon against challenges and a powerful way to connect with God's love and guidance.

"And the prayers of children are powerful. He (God) listens to the prayer of children," Mayugba added.

The World Children's

Day was established by Pope Francis to celebrate all the children in the worldwide Church.

Pope Francis himself led the main celebration held in Rome on May 25 and 26, while many dioceses around the world held activities for the special day.

"The Holy Father wants us to look at children as blessings. Children are blessings to the world, to families, to parents, and to the Church," Mayugba said.

# Marcos signs 'Eddie Garcia Law' to protect TV, movie workers

MANILA – President Ferdinand R. Marcos Jr. has signed a law on protecting and ensuring the welfare of movie and television industry workers, which stemmed from the demise of legendary actor Eddie Garcia while filming on set.

Marcos signed Republic Act 11996 or the "Eddie Garcia Law" on May 24, the Presidential Communications Office (PCO) said in a news release on Tuesday.

The new law mandates the implementation of work hours, wages and other wage-related benefits, social security and welfare benefits, basic necessities, health and safety, working conditions and standards, and insurance.

Under the law, the protection of the movie and television workers should also be in line with the Labor Code of the Philippines or Presiden-

tial Decree 442 as amended, and Republic Act 11058 or the "Act Strengthening Compliance with Occupational Safety and Health Standards and Providing Penalties for Violations" and other applicable laws, the PCO said.

The Eddie Garcia Law has taken into account the gravity of the accident that caused the death of Garcia while filming.

It mandates that the worker and the employer or principal shall execute an agreement or an employment contract in a language or dialect understood by both parties before the commencement of service.

"No agreement or employment contract shall discriminate against a worker who has contracts or projects with other production outfits unless exclusivity is specified in the contract, nor shall

any person perform any act involving preference based on race, color, descent, national or ethnic origin, or religion, which has the purpose or effect of nullifying the recognition, enjoyment, or exercise on an equal footing of any human right or fundamental freedom," the law's non-discriminatory provision stated.

As for the wages, the minimum wage of a worker shall not be less than the applicable minimum wage in the region where the worker is hired and wages shall be paid on time, as agreed upon in the contract, directly to the worker.

All workers shall also be covered by and entitled to benefits provided by the Social Security System (SSS), the Home Development Mutual Fund or Pag-IBIG Fund, and the Philippine Health Insurance Corp. (PhilHealth).

To ensure the health and safety of workers, the law mandates the employer to strictly comply with the occupational safety and health standards provided by the law.

Violators of any section of the law shall be fined up to PHP100,000 for the first offense; up to PHP200,000 for the second offense; and up to PHP500,000 for the third and succeeding offenses.

"If the violation is committed by a corporation, trust or firm, partnership, association or any other entity, the fines shall be imposed upon the entity's responsible officers, including, but not limited to, the executive producer, producer, production manager, and business unit manager," it stated.

Significant milestone  
Senators Robinhood Padilla, Jinggoy Estrada and Ramon Revilla Jr., meanwhile, thanked the President for signing RA 11996.

Padilla served as the principal author and co-sponsor of the measure in the Senate, while fellow showbiz personality Estrada sponsored the measure as chairman of the Senate labor committee.

"Very good news



enactment of the law is a "victory for the workers and the industry."

Lauded  
Speaker Martin Romualdez lauded President Marcos' signing of the Eddie Garcia Law, as it demonstrates the government's commitment to valuing the safety, rights, and well-being of workers.

"For ordinary Filipinos, this law means more than just new rules and regulations. It means that their safety, their rights, and their well-being are being taken seriously. It means that when they step onto a set, they can do their jobs with the confidence that they are protected and valued," Romualdez said.

Romualdez said Garcia's tragic loss underscored the urgent need for stronger protections for entertainment industry workers.

"His legacy has inspired us to take action and ensure that no worker has to face unsafe working conditions. The 'Eddie Garcia Law' is our promise to do better by our actors, crew members, and everyone who brings our stories to life," he said.

lighted the vital role of the entertainment industry in the country's culture and economy, stressing it is "high time" to ensure "those who work tirelessly to entertain us are given the respect and security they deserve".

1-Pacman Rep. Mikee Romero, stepson of the late actor, thanked President Marcos for signing the Eddie Garcia Bill into law.

"We would like to express our deep gratitude to the President for honoring the life of Manong Eddie, Manoy to family and friends, and his contributions to the entertainment industry," Romero said.

Romero, a principal author of the law, said Garcia's death highlighted the need for a safe workplace for entertainment industry workers, many of whom are self-employed independent actors, actresses and performers.

He said the accident served as a "wake-up call" for the industry and policymakers in Congress, resulting in the enactment of the legislation protecting the welfare of workers in the movie and television industry.

"Manong Eddie's untimely death was not in vain with the enactment of the law bearing his name," Romero said. (With reports from Wilnard Bacelonia/Filane Mikee Cervantes/PNA)
