President Duterte swears in newly appointed gov't officials

President Rodrigo Roa Duterte swore in Malacañang newly appointed government officials, rallying support for transparency and good governance, as well as elimination of corruption in government.

"I am confident that as you take your oath, you will also espouse our collective hopes and dreams and advance this administration's programs and initiatives to realize a prosperous future for all Filipinos," President Duterte said in a speech during the oath taking rites.

Stressing public office is a public trust, he said,

"I trust that you will perform your duties to the best of your [abilities], uphold transparency and good governance, and fight corruption in your respective offices."

He encouraged the newly appointed officials to lead by example and inspire their colleagues to embody honesty, humility, and simplicity befitting of a civil servant.

In fulfilling their mandate, the President urged them to use their resources wisely, develop policies and social programs conscientiously, and treat everyone equally regardless of ethnicity, status, religious belief, and political affiliation.

"With competent civil servants at the reins of our government offices, I am confident that we will maintain the program of government that you all desire and the public morale to the highest of expectations from

our people," he noted.

Meanwhile, the President broke his silence on the issue of House speakership saying he does not intend to support any candidate vying for the leadership of the House of Representatives.

He said during the oath taking that he did not make a commitment to endorse anyone for House speaker although some people sent some feelers asking for support.

Legarda on Ocean's Month: Save Our Oceans from Plastic Pollution



In celebration of the "Month of Ocean" this May, Senator Loren Legarda called on national and local leaders and citizens to help save our oceans from plastic pollution by implementing and educating ecological solid waste management practices within households and communities.

Legarda said that the Month of Ocean is annually celebrated during the month of May by virtue of

Presidential Proclamation No. 57, s. 1999 and that the theme for the 20th anniversary this year is "Free the Sea from Marine Debris," which focuses on the issue of marine debris and its effects to coastal and marine resources.

"Our oceans are primary sources of air, food, livelihood, and wealth for us Filipinos and people across the globe. I appreciate that we have now strengthened our efforts to protect marine life and re-

sources, but we need to urge our leaders and citizens a bit more to integrate ocean health protection into our consciousness and behavior," Legarda said.

Legarda lauded the collaborative efforts to rehabilitate Boracay and Manila Bay, but also encouraged local leaders and communities to fully implement the Ecological Solid Waste Management (EWSM), adding that Philippine communities that are faithfully implementing the law have reported

up to 80 percent waste diversion rate, which entails that much waste either recycled or composted.

Legarda noted the study by the Ocean Conservancy and the McKinsey Center for Business and Environment, which reported that the Philippines is one of the top countries with plastic waste in the ocean, with 2.7 million metric tons of plastic waste and half a million metric tons of plastic-waste leakage per year.

Senator Legarda, who filed Senate Bill No. 1948 or the "Single-Use Plastics Regulation and Management Act," also supported the campaign "Say No To Plastic Straws," launched as one of the activities for this year's Ocean's Month to inspire citizens and establishments to use alternatives to plastic straws.

"Let this year's celebration of Ocean's Month be a reminder that protecting our ocean's health is also protecting human health. May this further enable us to take action on sustainable management of our marine resources and ensuring that our oceans are free from plastic pollution," Legarda concluded.

Nat'l Geriatric Health: The need for an institutionalized center

MANILA -- With their wisdom and contributions to the country and to the economy, senior citizens are considered as the pillars and valuable members of every community. But needless to say, most of them are not properly cared for by their families and communities in their twilight years.

Dr. Melhammid Tomawis, chair of the National Center for Geriatric Health (NCGH), in an interview, told the Philippine News Agency (PNA) that senior citizens comprise more than 10 percent of the national population.

"There are more than 10 million senior citizens in the country and that is significant. They are the core foundation of our country, they have contributed to the taxes while they were still strong and working hard," he said.

Tomawis said that these senior citizens worked for their children, who became lawyers, engineers, among others, adding that they have a lot of contributions to our history because many of them fought during wars.

Tomawis said that senior citizens deserve all the medical care and assistance they could get from the government.

"It's good that we now have discounts for maintenance medicines, diabetes and hypertension, but it's not enough. They need a medical facility for their unique health conditions," he said.

Citing the importance of pediatric and obstetric departments in hospitals, Tomawis emphasized the need for a geriatric hospital which could attend to their emergency health needs and provide therapies and other treatments for older adults.

Geriatrics is a branch of medicine that focuses on the health care of elderly people through prevention and treatment of their diseases and disabili-

ties.

NCGH institutionalization needed

The NCGH is part of former president Gloria Macapagal Arroyo's social safety net and health services programs which aim to provide for the special needs of the senior citizens nationwide. It was inaugurated on May 27, 2010.

"Since 2010, this has been renovated many times and the equipment for dialysis and other tools are here but this hospital is not operational because there is no law which allows it to operate. This is just an OPD (outpatient department) under Jose Reyes Memorial Center from Monday to Friday," said Tomawis, adding he has been pushing for its institutionalization for nine years now.

Tomawis has seen a "ray of hope" under President Rodrigo Duterte's administration because "it opened the hospital for admission but for mild cases only".

"The emergency room here is not complete. The pharmacy is not open 24 hours and the medicines are incomplete. If there are patients, they are brought to the Jose Reyes Hospital," he added.



Construction of LRT1 Cavite extension commences

BACOOR CITY, Cavite, (PIA) – The construction of the LRT1 Cavite extension recently commenced after its initial groundbreaking ceremonies two years ago.

The event was attended by Congressman Strike Revilla and then-Parañaque city mayoral candidate Edwin L. Olivarez and officers of the De-

partment of Transportation.

The project was awarded to the Light Rail Manila Corporation (LRMC) five years ago with estimated cost of P64.9-billion and is projected to be completed and operational on October 2021.

It will attach eight more stations from Baclaran to Bacoor, Cavite: Redemptorist,

MIA, Asia World, Ninoy Aquino, Dr. Santos, Las Piñas, Zapote and Niog and would lessen travel time from Cavite to Baclaran and vice versa to less than 30 minutes.

The said project is a Public-Private Partnership (PPP) and is part of President Duterte's Build, Build, Build

program and would help solve traffic congestion in Aguinaldo Highway from Coastal road and other affected thoroughfares in the south.

It will also give an alternative mode of transportation to the resident commuters in Parañaque, Las Piñas and Cavite area. (Ruel Francisco, PIA-Cavite)

DENR mulls local production of engineered fuel



MANILA -- Department of Environment and Natural Resources (DENR) isn't discounting the possibility of eventually ending Philippine importation of waste-based processed engineered fuel (PEF), an alternative to fossil fuel used in cement production.

DENR is looking into possible production of PEF in the country so cement producers can buy this product from local sources instead of sourcing it abroad, DENR Undersecretary Benny Antiporda said.

"They won't have to import PEF," he said.

News reports this week cited Bureau of Customs as intercepting, in Misamis Oriental province, shipment originating from Australia and declared as PEF consigned to Holcim Philippines Inc. for this company's use in cement production.

DENR's Environmental Management Bureau (EMB) confirmed the shipment is PEF, as noted by the agency's hazardous waste chief Gerry Sañez.

"PEF can be imported as it's tradable commodity and not mere waste for disposal," he also said.

Wood chips, textile, recyclable plastics, cardboard and paper are among waste materials that can be used in making PEF, said Irvin Cadavona, EMB environmental management specialist. He said when burned, PEF emits lesser carbon dioxide compared to fossil fuel.

"As far as I know, there's no PEF processing plant in the country yet but it's good to have this so the commodity can be produced locally," he said. (PNA)

wherein they will play a major role in the implementation of health programs for the province-wide and city-wide health system that will be put in place in the two selected provinces," Janairo explained.

He stressed that under the province-wide and city-wide health system, a BHW will be the primary care providers, tasked to extend primary, promotive, curative, rehabilitative and palliative care to those in need.

In addition, the BHW will also act as an information aide in the collection of data and basic information on patients at the local level.

"This network will be providing people-centered and comprehensive care in an integrated and coordinated manner with the primary care provider or navigator who will be the coordinator of health care within the network," he said. (PNA)

Senior citizens who attended the event enjoyed free acupuncture, acupressure therapy, massage therapy and haircut while being serenaded by Dondi Ong and his group. Ong is a hall-of-famer of Aliw Awards for performing the Phantom of the Opera in many countries.

"The harana (serenade), singing of kundiman (native songs) is part of music therapy for the old people. Music makes them feel relaxed and happy and when they're at that state, no depression, the onset of dementia is delayed," Tomawis explained.

Agapita Ayubo, 76, said she enjoyed listening to the kundimans at the event.

"Naririnig ko po nung kabataan ko iyong mga kundiman. Masaya po kapag nag-iipon-ipon kasi, marami kang makakausap, kasi po ang memory natin parang nawawala na rin kapag lagi ka lang sa bahay at lagi lang trabaho (I listened to the kundiman when I was young. I'm happy when people gather together because you're able to talk with other people because your memory fades when you're just at home and you're focused on work only)," she added.

Apart from a new pair of reading glasses, Nanay Agapita received free check-up, x-ray and ECG (electrocardiogram).

"Malaking bagay po na libre kasi po ang pinansiyal ko po ay kulang. May anak po ako pero wala pong allowance na nabibigay sa akin. Malaking tulong po sa aming matatanda na kumpleto ang aming pagpapatingin (This is a big help because I'm lacking financially. I have a child but I'm not given allowance. This a big help for us senior citizens to have complete checkup)," she said.

Nanay Agapita added she and other senior citizens like her "would be happier and more grateful to the government" if the NCGH becomes fully operational.

"Matatanda na kami, kaunting panahon ang ilalagi namin dito. Maganda hindi po ba kung natutugunan po talaga panganagilangan naming pangkalusugan (We're already old, we'll be here [alive] for a short time only. It would be nice if our health needs are met)," she said. (PNA)

FILE SOCE ON OR BEFORE JUNE 13, WINNERS TOLD



TRECE MARTIRES CITY, Cavite -- The Department of the Interior and Local Government (DILG) in Cavite is reminding newly-elected officials in the province that they only have until June 13 to file their statements of contributions and expenses (SOCE) or they risk being barred from assuming their posts.

DILG-Cavite Director Eloiza Rozul said that candidates, specially the winners, must submit their SOCEs to the Commission on Elections (Comelec) on time as they may not be allowed to assume office until they have complied with the requirement.

If a candidate fails to file his/her SOCE, the law states that the offender shall be subject to perpetual disqualification from holding public office.

Late submission of SOCE entails a penalty of PHP8,500 for provincial political parties; PHP8,000 for provincial governors and vice governors; PHP7,000 for provincial board members, congressmen, local political parties, mayors, and vice mayors; and PHP6,000 for councilors. (PNA)



DOH taps Calabarzon barangay health workers as UHC frontliners

CALAMBA CITY, Laguna -- Barangay (village) health workers (BHWs) are being tapped by the Department of Health (DOH) regional office in Calabarzon as frontliners in the implementation of the Universal Health Care (UHC) law, particularly at the two pilot sites in Batangas and Quezon.

This, as the DOH-Calabarzon prepares for the UHC implementation by strengthening the province-wide health care delivery system by first training BHWs for their enhanced role.

DOH-Calabarzon Regional Director Dr. Eduardo C. Janairo told PNA on Wednesday that the capability training for the BHWs aims to enhance their capacity and prepare them for their role as "navigators" in pursuit of the new UHC law signed by President Rodrigo Roa Duterte on February 20 this year.
