GOVERNMENT ENCOURAGES PUBLIC TO INVEST EARLY

The public is encouraged to invest for a retirement fund at an earlier age under Personal Equity & Retirement Account (PERA) or known as the Republic Act No. 9505 or the PERA Act of 2008.

PERA is a voluntary retirement savings program, established by and for the exclusive use and benefit of the contributor on top of the retirement benefits from the Social Security System (SSS) from the private sector and Government Service Insurance Sys-

tem (GSIS) from the public sector, and employers. It has voluntary portability where it can be carried over even in the change of employer from private to public or vice versa.

PERA Contributor can be employed, self-employed and overseas Filipinos with a maximum Php100,000 per person annual contributions in a yearly flexible payment.

For married couple investment, a maximum of Php100,000 each per annum while
