MANILA - The government is committed to building more "safe, quality, and comfortable" housing units in the country, President Ferdinand R. Marcos Jr. said Friday.

Marcos gave the assurance, as he led the awarding and groundbreaking ceremonies for the National Housing Authority's (NHA) new housing projects in Bacoor, Cavite.



This is similar to the emergency warning in Japan when the country was struck by a powerful earthquake on New Year's Day, Galang pointed out.
