Gen. Trias mayorelect to focus on city's waste problem

TIRES, Cavite (PIA) General Trias City mayor-elect Jonjon Ferrer aims to focus on the local waste problem in his first 100 days as the city spends an estimated P250 million per year on garbage disposal alone, .

He stated this in a recent interview on One News PH channel with Cheryl Cosim and Jay Taruc.

According to Ferrer, he will focus on this problem as local government is reportedly studying to reduce the amount of waste disposal in the city, in conjunction with the adjustment of waste segregation from

the household level.

He also plained that with the increase in population the amount of garbage has also doubled.

Ferrer also said in the interview that while he and outgoing-Mayor and Congressman-elect Antonio "Ony" Ferrer have different leadership styles they share a similar goal to improve the lives of residents and make General Trias more progressive.

Calamba commemorates 161st birth anniversary of Dr. Jose Rizal

CALAMBA CITY, Laguna (PIA) — The provincial government of Laguna and the city government of Calamba commemorated the 161st birth anniversary of Dr. Jose P. Rizal on Sunday, June 19 in Jose Rizal Shrine, Calamba City, Laguna.

Officials from the provincial government headed by Governor Ramil Hernandez, and the city government headed by Mayor-elect Roseller Rizal led the flag-raising and wreath-laying ceremony. Also present at the event is Commissioner Emmanuel Calairo of the National Historical Commission of the Philippines (NHCP).

A wreath from President Rodrigo Roa Duterte was also presented on Rizal's statue on his behalf.

Hernandez lauds the heroism shown by the frontliners during the onslaught of the COVID-19 pandemic and proclaimed that their selfless act is in itself a heroic one. MANILA -- The Department of Science and Technology - Science Education Institute (DOST-SEI) on Tuesday warned the public against "suspicious" social media accounts, misleading information on its scholarship programs, as well as fake job offerings.

These suspicious accounts bear SEI's name, logo, or its flagship scholarship program.

"The Institute has recently come across numerous websites, and Facebook pages with misleading information about scholarship programs, including fake job offerings," it said in an advisory.

The SEI cited two Facebook accounts as ex-
