



with Metrology, Rubber, Halal, Food and Drinking Water Safety, Food Innovation Centers, and SETUP, with plans to broaden laboratory services. OneLab collected a total of Php724,064,255.27 from 2017 to 2021, equivalent to an average of Php144,812,851 fees collected annually, and has since been reverted to the national treasury.



Undersecretary Cheloy Garafil, officer in charge of the Office of the Press Secretary (OPS), made the assurance during the dialogue with various media organizations in Camp Crame after the recent unannounced police visits to the residences of some journalists.
