TRECE MARTIRES CITY - The regional wage board issued an order granting an increase of P35 to P50 in the daily wage of workers in the region, the Department of Labor and Employment (DOLE).

The National Wages and Productivity Commission said the wage order, which was issued on Sept. 1 would take effect on Sept. 24. With the wage hike, the daily salary of workers in the non-agriculture sector will increase from P385 to P520, agriculture sector P385 to P479, and retail and service establishment with more than 10 workers, P385. Workers in

the agriculture sector in Calaca, Batangas and Carmona, Cavite will get an increase to P89 due to their reclassification from first class municipalities to component cities.

MANILA – The Department of Transpor- ito ay magkakaroon ng lanes nationwide (We tation (DOTr) on Monday broke ground for the establishment of 76.70 kilometers of protected bike lanes across the cities of Lipa and Batangas City in Batangas and the cities of Antipolo, Cainta and San Mateo in Rizal.

The bike lanes, with a total approved budget of PHP151.7 million under the 2022 General Appropriations Act, are expected to be completed by the first quarter of 2024.

The project is part of the government's Active Transport Program that aims to provide "sustainable and seamless" active transport not only in Region 4-A (Calabarzon) but also nationwide

DECREE OF DECLARATION OF ABSOLUTE NULLITY OF MARRIAGE

On 24 April 2023, a decision was rendered in the above-mentioned case, the dispositive portion of which reads as follows:

"WHEREFORE, in view of the foregoing disguisition, the Petition is hereby GRANTED on the ground of lack of marriage license. Land Transportation Office chief Assistant Secretary Atty. Vigor Mendoza II directed all regional directors and heads of district offices of the agency to implement the extension of the validity of driver's license.

In a memorandum dated September 6, Mendoza said, "All expired driver's/conductor's licenses that expired on 03 April 2023 shall continue to be valid until 02 April 2024 or until such time availability of plastic cards is sufficient, which will be the subject

of a separate memorandum."

Mendoza noted that no collection of penalties for the abovementioned licenses shall be undertaken.

Mendoza further tasked concerned LTO personnel that the system generated driver's license official receipt shall be stamped or printed with "Valid as Temporary Driver's License Until Plastic Card is Released," and that it should include the following details:
