Ang buwan ng Marso ay Women's Month, o Buwan ng Kababaihan. Ipinagdiriwang ito sa buong mundo bilang pagkilala at pagpapahalaga sa papel na ginagampanan ng tinatawag nilang "the weaker sex" sa pagbuo ng komunidad at pagpapaunlad ng bayan. Noong panahon ng Hapon, ang kababaihan ay pambahay lamang, tagapag alaga ng anak, tagapagsilbi at taga-aliw ng kabiyak, tagalaba, tagaluto, tagapamalengke, tagalinis at iba pang "taga".

Nagbago ang panahon, nag bago rin ang pananaw ng mga babae ukol sa kanilang dapat kalagyan, nagbago ang papel na kanilang binibigyang buhay. Weaker sex? Not anymore higit na silang malakas, matapang at matatag ngayon. Napatunayan na sa ibat ibang larangan at pagkakataon na kayang makipag sabayan ng mga kababaihan sa tikas at husay ng kalalakihan.

Ang top 4 ay ang Pilipinas, 46.7 percent na kababaihan dito ay mga bossing ng mga korporasyon. Sa pulitika, serbisyo publiko, sa negosyo, edukasyon, sining at kultura, sa pagbabatas, at pamamahayag, sa tahanan, sa Simbahan, saan mang sektor ng lipunan, maayos at matatag na naiposisyon ng mga kababaihang may likas at natatanging kakayahan ang kanilang sarili upang mamuno.

Sa kabila nito, may mga bagay pa rin namang hindi kayang gawin o mahirap para sa babae na gawin, subalit marami rin namang mga bagay na hindi kayang gawin ng mga lalaki. kaya amanos lamang, Kaya dapat ay maging pantay ang pagtingin ng lipunan sa mga kababaihan at kalalakihan. Calabarzon LGUS implementing online classes due to week-long transport strike



AKIA SOUTHERN LUZON, PIA Calabarzon to collaborate in promoting ease of doing business



CALAMBAITY, Laguna (PIA) — The Anti-Red Tape Authority (ARTA) Southern Luzon is partnering with the Philippine Information Agency (PIA) Calabarzon to strengthen public awareness and understanding of anti-red tape policies and ease of doing business in the Calabarzon region.

CALABARZON— The week-long transport strike of various transportation groups from March 6 to 10 prompted several local government units in the Calabarzon region to declare online set-up for classes.

The Department of Education earlier said classes should continue despite the transport strike, pointing out that learners affected by the move of transport groups may resort to other learning modes.

1. Cavite Province

Cavite Governor Jonvic Remulla has ordered the conduct of asynchronous classes in both public and private schools covering all levels in the province. Remulla said this would enable learning to continue despite the difficulty of commuting during the strike.

2. Laguna Province

Laguna Governor Ramil Hernandez on Sunday issued Executive Order No. 2, s. 2023, mandating public and private schools in all levels to conduct asynchronous classes from March 6 to 10.

3. Angono, Rizal

In Executive Order No. 2023-10, Angono Mayor Jeri Mae Calderon enjoined public and private schools to hold online classes during the period. Calderon also encouraged private business establishments to adopt remote work setups.

4. Cainta, Rizal

Cainta Mayor Elen Nieto also called on public and private schools to conduct online classes during the transport strike.

"Schools can adopt other measures so as not to disrupt classes and to
