(PIA) - - The House of Representatives approved on second reading Wednesday House Bill 8858, seeking to lower the minimum age of social responsibility from 15 years old to 12 years old.

The bill, principally authored by Majority Leader Fredenil Castro, expands the scope of the juvenile justice and wel-

ens the social reintegration programs for children in conflict with the law, amending Republic Act 9344 or the Juvenile Justice and Welfare Act of

"In this case, its very clear and apparent that the committee report of the Committee on Justice proposing for a minimum age of social responsocial responsibility, was moved from nine to 12. It was the consensus of the group," House Committee on Justice chair Rep. Doy Leachon (1st District, Oriental Mindoro), who sponsored the bill on the floor,

Leachon added that an overwhelming majority of House Members welcomed the shift pegnew minimum, including all the co-authors of the measure.

Leachon stressed that the measure focuses on safeguarding children through reform and rehabilitation.

He further shared that most of the changes approved at the committee level which include changing the term "minimum

bility" to "minimum age of social responsibility" were carried over into the most recent version of the bill.

## ANGARA BATS FOR CREATION OF **GOV'T BODY FOR SENIOR CITIZENS**

Senator Sonny Angara has filed a bill that would create a government agency devoted to attending to the needs and concerns of senior citizens.

Senate Bill No. 2099 calls for the creation of the Council for the Welfare of Senior Citizens (CWSC) under the Office of the President that would formulate, coordinate and monitor policies and programs that promote the rights and privileges of the senior citizens'

"Our Filipino citizens have contributed immensely to the growth and progress of the country. As they reach the twilight of their lives, it is our responsibility as a society to respect, protect and promote their rights and assure their physical, mental and social wellbeing," Angara said.

Based on the 2010 census, there were 6.23 million Filipinos aged 60 years and above. Its projection showed that the number would reach double digit

Senate, House Convene Bicam on 2019 Budget: The Senate and the House of Representatives convened on Tuesday, January 22, the bicameral conference committee to reconcile the differences in their respective versions of the proposed 2019 national budget worth P3.757 trillion. Senator Loren Legarda, Chair of the Senate Committee on Finance, said that the bicameral panel will use the 2019 National Expenditure Program (NEP) as point of reference, but will also consider the House and Senate versions of the General Appropriations Bill (GAB).

## **DBP** partners with LGU GenTri

General Trias City, Cavite (PIA) - The Development Bank of the Philippines (DBP) recently entered into a partnership agreement with the local government of General Trias to further improve its administration and provision of services to its constituents.

The undertaking will involve projects for the automation of its human resource and payroll processing and the setting-up of Point-of-Sale system (POS) and internet payment gateway (IPG) facilities.

"With the POS facility, residents and business owners in General Trias City can now pay their real property taxes using debit, credit and prepaid cards, while the IPG would facilitate online acceptance of payments of the taxpayers' real property and business dues, "DBP president and chief executive officer Cecilia Borromeo said.

DBP will also install two additional ATMs in the city to serve the local government's employees and its residents.

**General Trias City** Mayor Antonio Ferrer explained that these improvements will help the city government create payment options for the convenience of its resident constituents which will result to increase in tax collections as well as efficiency in services provided to residents and generate savings from decrease in operational expenses. # CALABARZON DA 4A to harmonize interventions for better service

CALAMBA CITY, Laguna, (PIA) – For this year, the Department of Agriculture Region 4A (DA 4A) aims to harmonize their interventions to avoid redundancy of programs and better cater the needs of their beneficiaries.

dren in conflict with the law.

Under the House panel's proposed bill, the Department of Social Welfare and Development will build, fund and run Bahay Pag-asa facilities. Congress will allocate funds for Bahay Pag-asa annually.

It would be noted that in a Senate hearing, Tricia Oco, executive director of the government's Juvenile Justice and Welfare Council, lamented on the subhuman conditions of some "Bahay Pag-asa" due to budget constraints.

"They lack the minimum staff requirement; they even lack food for children. Some of the Bahay Pag-asa that we saw are worse than prisons. They don't have programs, beds and cabinets," Oco told the Senate committee on justice led by Sen. Richard Gordon Tuesday

Oco added that there are only 63 Bahay Pagasa facilities nationwide, five of which are no longer operational.

Under the provisions of the measure, a child under 18 years old who commits a petty crime shall not be subjected to mandatory confinement in a Bahay Pagasa facility.

Mandatory confinement shall be implemented if the crime committed by the child in conflict with the law is a serious offense; if they are neglected children, meaning they do not have a family; or if it is a case of recidivism.

If there is no Bahay Pag-asa facility in the area to cater to the child, they will be temporarily released on recognizance to their parents. (PIA-NCR with reports from Press and Public Affairs Bureau/House of Representatives)

Dr. Edgardo Figueroa is the head of ONI's medical staff of at least 20 doctors, 25 nurses and 15 consultants, including specialists who will be available 24/7 to provide treatment and care and also perform minor and major surgeries.

Barely a week after it opened, ONI had its first successful childbirth on October 18, 2018. A baby girl weighing 1.95kg was delivered for free since it was ONI's first week of operation and was in time for Mayor Emmanuel L. Maliksi's birth month.

## DOH LEADS OBSER VANCE OF GOITER AWARENESS WEEK (GAW) 2019

The Department of Health (DOH) today leads the nation in observing the Goiter Awareness Week (GAW) 2019 with the theme, "Goiter Sugpuin, Isip Patalinuhin, Iodized Salt Gamitin," which aims to highlight the vital role of iodized salt in preventing thyroid disorders such as goiter. Partners and stakeholders like the Philippine Thyroid Association, Philippine Society of Endocrinology, Diabetes and Metabolism, Iodine Global Network, National Nutrition Council and DOST-FNRI will also disseminate information and educate the public on the effects of iodine deficiency.

According to the 2012 Philippine Thyroid Diseases Study (PhilTiDes-1), the prevalence of thyroid function abnormalities in the Philippines is 8.53% among the adult population, and among the thyroid disorders, goiter is most common with a prevalence rate of 10.12%.

Meanwhile, the 2013 National Nutrition Survey revealed that about 5.8 million Filipinos were afflicted with thyroid disorders in different clinical presentations. These manifest as goiter, thyroid malignancy, mental deficiency, physical deformities, congenital hypothyroidism, cretinism, and reproductive failure. If untreated, these disorders could lead to the detrimental reduction of intellectual and physical capacity and even death among susceptible individuals.

People with goiter often have an abnormal enlargement of the thyroid gland which can lead to the appearance of a mass or swelling in the neck. The signs and symptoms of goiter can be varied and may include tiredness, a decrease or increase in weight, low or increased appetite, depression, dryness of skin and hair, sleepiness, diarrhea or constipation and menstrual irregularities (for women). People who experience these symptoms should immediately see a doctor.

Since iodine deficiency is the most common cause of goiter in the Philippines, people are advised to use iodized salts in their meals and to eat food rich in iodine such as dairy products, seafood (shellfish and seaweeds), meats, bread and eggs. Special attention should be provided to pregnant women because iodine deficiency during this critical period can cause premature birth, miscarriage or delivery of a baby with low intellect.

To address this health concern, the DOH, in collaboration with different organizations, will be conducting a Partner's Forum and Basic Thyroid Course on January 23, 2019 in Baguio City at Venus Parkview Hotel. The campaign aims to disseminate the ill effects, prevention, and signs and symptoms of goiter or bosyo in Filipino.

Goiter Awareness Week is observed every 4th week of January of every year declared under Presidential Proclamation 1188 on December 11, 2006.

It's going to be a continuing one."

Duterte's war on drugs has been continuously subjected to various criticisms from the religious and civil society groups but the President maintains the effects of drugs have wreaked havoc to families, making some of them dysfunctional, and to the community, in general with crimes such as robbery, rape, and murder.

Calabarzon region, as well as its provincial offices in Pampanga and Bataan, will also be involved in the rehabilitation efforts.

He also underscored the need to "clean the water source, so as to put an end to pollution."

"We need to find out where the outfalls come from individually, because in just one estero we can find lots of outfalls," Cimatu pointed out.

A list of local establishments that violated environmental laws will be released on Jan. 27, Cimatu revealed.

Although Manila Bay is still known for having one of the most beautiful sunsets, its waters are considered the most polluted in the country due to domestic sewage, toxic industrial effluents from factories and shipping operations, and leachate from garbage dumps, among others.

Cimatu said the waters along the Roxas Boulevard, which has the best view of the sunset, is even "worse than Boracay."

"We have seen the problem closely this time, and we have already laid out a detailed solution," he added

The DENR's goal, he said, is to bring down the coliform level in all esteros to 100 most probable number (MPN) per 100 milliliters (mL).

Cimatu shared that reforestation of mangrove areas in the Las Piñas-Parañaque Critical Habitat and Ecotourism Area or LPPCHEA is also included in the rehabilitation plan.

The DENR chief also bared that Malacañang has approved a budget amounting to P42.95 billion for three years. This amount will cover cleanup of priority waterways, relocation of informal settler families (ISFs), and implementation of temporary sanitation facilities in ISF communities prior to relocation.
