## P723M invested for 2 new ecozones in Cavite



MANILA - The Philippine Economic Zone Authority (PEZA) said the two newly proclaimed special economic zones in Cavite province have investment amounting to PHP723 million.

In a statement Monday, PEZA said that these investments came from the expansion of

Gateway Business Park for another 2,898 square meters of land.

The expansion project, costing PHP380 million, will be hosting a metalwork locator.

As of June 2024, the ecozone in General Trias has 28 locators with aggregate exports of USD430 million annu-

ally. The ecozone also employed 29,000 Filipino workers.

Meanwhile, the NDC Industrial Estate in Dasmariñas has investments amounting to PHP343 million.

## Rabies cases hike by 23%-DOH

MANILA - The number of rabies cases nationwide increased by 23 percent or a total of 354 from Jan. 1 to Sept. 14, the Department of Health (DOH) said Friday. The total was higher than the 287 cases logged during the same period in

Data also showed that in August, an increase in rabies cases was observed in the National Capital Region, Ilocos Region, Cagayan Valley, Bicol Region, Central Visayas, Eastern Visayas, Zamboanga Peninsula, Northern Mindanao, Davao Region and Soccsksargen.

Rabies is preventable through vaccination of pets and persons.

Individuals bitten by animals should seek immediate medical attention and if necessary, have post-exposure prophylaxis to prevent rabies infection.

Earlier, Agriculture Secretary Francisco Tiu Laurel Jr. said that PHP110 million is needed to vaccinate around 22 million dogs and cats.(PNA) By Ma. Teresa **Montemavor**



# ROTC bill now a top priority at the Senate

MANILA – The Senate will prioritize Senate Bill (SB) No. 2034, or the proposed Reserve Officers' Training Corps (ROTC) Act, as soon as session resumes in November, Senate Majority Leader Francis Tolentino said on Monday.

Tolentino made the assurance after President Ferdinand R. Marcos Jr. gave his approval in the recent Legislative Executive Development Advisory Council (LEDAC) meeting.

"With the President's go signal, the ROTC bill has been moved to Tier 1 from Tier 2 in the list of the LEDAC – making it a top priority. So, when the session resumes, we expect to dis-

cuss it right away," he said in a statement.

He said issues like the program's duration and curriculum, including subjects on climate change, disaster preparedness, and civics, are being considered.

Tolentino is also exploring options for smaller colleges to offer ROTC through resource pooling.

"We can make the first year the basic course, followed by advanced training in the second year. For those who wish to specialize further, we can introduce an Executive ROTC curriculum," he explained.

Tolentino noted that the growing participation in ROTC Games and increased

interest among female cadets indicate a positive shift in public perception.

He also believes that ROTC can foster patriotism among the youth amid concerns in the West Philippine Sea. source:(PNA)
