



The Cavite Provincial Health Office thru its Area Regional HIV Program Coordinator, Mr. Symson G. Maquera, and Provincial HIV Program Coordinator, Ms. Haydelisa Maderazo, conducted a three-day training on clinical management for STI, HIV and AIDS to the medical team of the Bureau of Jail Management and Penology (BJMP) in the province on June 27-29, 2022 at Quest Hotel in Tagaytay City. The training which was done in partnership with the Pilipinas Shell Foundation, Inc. thru Mr. Russell Q. Tabisula, Deputy Program Manager for Field Operations, sought to equip the participants with the principles and strategies on the holistic management of person deprive of liberty (PDL) patients with HIV and AIDS.

For the preliminaries, Mr. Cesar Teves, Quest Hotel Safety Officer discussed some health and safety protocols imposed by their facility immediately followed with a welcome message of Dr. Armand J. Dotollo, Head - Communicable and Non-communicable Diseases. Levelling of expectations from the training and resource speakers was also done before the training proper.

The 3-day training was filled with relevant and sufficient information needed by BJMP medical team in the clinical management of sexually transmitted infection, HIV and AIDS in their respective work assignments. Resource speakers were Dr. Ma.Hilda C. Bucu, Noveleta Municipal Health Officer, Dr. Michael Angelo J. Marquez, Medical Officer III at Bacoor Hygiene Clinic, Dr. Ferdinand Mina, OIC-Municipal Health Officer in Imus City Social Hygiene Clinic, Dr. Anna Maureen Villamar, HIV/AIDS Core Team Physician in GEAMH Treatment Hub, and Mr. Symson Maquera who delivered a comprehensive presentation.

Dr. Bucu discussed Sexually Transmitted Infection (STI), Human Immunodeficiency Virus (HIV) and Acquired Immuno Deficiency Syndrome (AIDS) 101. The talk focused on the basic information on STI, HIV and AIDS including its testing, mode of transmission, prevention and treatment. Likewise, she briefly tackled the policy and mandates of RA 11166 also known as the Philippine HIV and AIDS policy act.

These were further supported by the topics lectured by Dr. Marquez which include the Clinical Management of STI, Nursing Roles of Nurses in HIV Care, Enhancing Linkage to Care for Persons Living
