DOH-CALABARZON FORMS TASK FORCE AMIDST RISING MEASLES CASES

The Department of Health in Calabarzon has created a task force to guarantee the implementation of the government's mass immunization drive against measles amidst rising cases in the region.

In a statement, DOH Director for Calabarzon Eduardo Janairo said the measles task force will ensure that strategies and plans are carried out and, at the same time, address the needs of measles patients.

"We need to have a uniform strategy (in the mass immunization activity) espe-

# Universal Health Care Act assures cover for all - PhilHealth

The Philippine Health Insurance Corporation (PhilHealth) confirmed recently that all Filipinos would surely receive health care services, without heavy financial burden due to costly treatments when the Universal Health Care (UHC) bill is signed into law by President Rodrigo Roa Duterte.

This was disclosed recently by Dr. Roy B. Ferrer, acting PhilHealth president, adding an encouraging note as the entire nation awaits the historic prospects when the UHC bill becomes a law.

The said bill was approved by both the Senate of the Philippines and the House of Representatives early last month, and was thenceforth transmitted to Malacañang last January 23rd. The President is expected to act on the bill in 30 days.

"We are on the verge of a new era not just for the health sector but for the entire country. It is only a matter of time that real and profound changes will take place that will surely be felt by our countrymen," Ferrer said.

The PhilHealth chief said that the UHC aims to automatically include all Filipinos in the National Health Insurance Program, and grant them immediate eligibility to claim the benefits when needed.

Ferrer revealed that over 100 million Filipinos are currently covered by PhilHealth. With UHC, the remaining six million of the population will soon be included and provided with health insurance.

The PhilHealth Chief added that the state health

insurer has mechanisms in place, so "it can truly fulfill the law's mandate, pending the issuance of the UHC law's implementing rules and regulations (IRR)."

"Non-members are assured that, under the UHC act, every Filipino will be treated by any PhilHealth accredited hospital," Ferrer declared.

The state agency also declared that soon after the UHC law's IRR is completed, all 106 million Filipinos can expect a better level of coverage and improved services from PhilHealth and from the country's entire health sector in general.

PhilHealth's Point-of-Service Program will enable patients to avail of PhilHealth's health care facilities, provided they are confined in government facilities. "Even women who are about to give birth are guaranteed coverage using the same process, whatever health facility they are admitted into," Ferrer said.

The PhilHealth top executive assured that active PhilHealth members remain fully entitled to their PhilHealth benefits.

By law, paying members such as those employed and self-paying, should continue remitting their premium contributions, Ferrer emphasized, adding that "this member support will ensure the stability of our fund."

"The poor and senior citizens remain covered as guaranteed by various laws for as long as they are qualified." Ferrer emphasized.(END)

# 'Sumilang' Festival 2019, a celebration of the faithful

SILANG, Cavite -- The 9th Sumilang Festival, which is celebrated in this historic town from January 20 to February 8, comes with pomp and pageantry but with more meaningful celebration for the town's 424th founding anniversary and homage to its patron saint "Our Lady of Candelaria".

Phillip Lacson Medina, chairman of the Sumilang Fiesta Executive Committee and member of the Silang Heritage Council, shared that this year's celebration also marked an event by the faithful community with the Episcopical coronation for the Blessed Mother of Silang by Bishop Reynaldo Evangelista of the Diocese of Imus on January 31.

Medina said the town was originally established as a parish on Feb. 3, 1595. Thus, present officials of the Silang Parish Council for Culture and Heritage (SPCCH) and the Parish Pastoral Council (PPC) filed a petition, through their Parish Priest Marty Dimaranan, before the Imus Bishop who granted the request for the Episcopal coronation in celebration of its 424 years as a parish.

"Credit also goes to various religious organizations with the barangay-based Basic Ecclesial Communities (BEC) who led the fundraising campaign from the faithful, and the proceeds were used to purchase the sterling silver fineries and regalia in honor of the Blessed Mother's devotion to the community of Silang," he added.

Medina described the solemn occasion spirited by the 120-strong choir composed of men, women and children as they led the congrega

tion in the "Awit ng Papuri" (song of praise) as the coronation procession ensued.

As part of the ceremony, the community organizations offered two silver crowns to the bishop while a youth representative, as part of the church's observance for the "Year of Youth", brought the silver candle to the altar.

Medina said the sacred rites were amazing, bringing goosebumps to the congregation, as they witnessed Rev. Father Marty Dimaranan place the first crown to the Santo Niño image.

As Bishop Evangelista crowned the Blessed Mother, the parishioners chorused to rousing and joyful shouts "Viva de la Virgen de Candelaria! Viva Reina de Silang! (Hail to the Blessed Virgin of Candelaria! Hail to the Queen of Silang!).

"It was an emotional pandemonium for the crowd as others gleefully cheered while others cried in joy," Medina said.

The traditional homage to the town's patroness "Our Lady of Candelaria" took centerstage during the 20-day festivities in the centuriesold church, which parish edifice complex showcases the Retablo Mayor and Mayores, or the votive altar pieces that were conferred as National Cultural Treasures (NCT), through a historical marker installed by the national museum.

Festival organizers said the annual Sumilang Fiesta is observed as thanksgiving for the bountiful fruit harvests in this agricultural but firstclass town.source: (PNA)

ture Office, which also supervises animal control, has seen the registration of some 17,793 dogs and 1,048 felines that were vaccinated in 2018 and is bent on increasing the record by at least 10 percent.

Fund (PDAF) allocation.

cially in the recording, reporting and monitoring of cases," Janairo said in a meeting on February 11 attended by local government health officers, national immunization program coordinators, and other officers involved in the campaign.

He added: "This is also to ensure that we have enough supply of vaccines at the local level including health human resources who will administer it to the target population."

Janairo said the task force will involve local government leaders and ensure that logistics are in place.

Based on the DOH's Regional Epidemiology and Surveillance Unit (RESU), at least 972 measles cases have been recorded in the region from January 1 to February 9, 2019 with 25 confirmed deaths or up by 683 percent compared to last year's 124 cases and 1 recorded death for the same period. The age of measles cases this year ranges from 9 months to 59 years old. Records also

showed of the 972 measles cases, 202 were vaccinated leaving 359 without vaccine; 192 were below 9 months old; and 174 have unknown vaccination status.

**Rizal** Province charted the highest number of measles cases with 465 followed by Laguna with 167, Batangas with 142, Cavite with 126, and Quezon with 72.

Meanwhile, the logovernments have cal

beefed up immunization activities to control the spread of measles.

In Antipolo City, the City Health Office has been conducting various Measles-Rubella Supplementary Immunizations in various barangays and sitios beginning January 28 and will continue until February 28.

Pililla town in Rizal will provide health reminders to various religious entities in the town such as the Roman Catholic Church, Iglesia ni Cristo, and Seventh Day Adventists, among others.

Places for vaccination will be assigned by the Pililla Municipal Health Office while various non-government agencies and schools have expressed support for the campaign and the Armed Forces of the Philippines will provide support for the immunization activities to be held in areas with armed conflict.

Vaccination sites will be set up in local fast food chains and churches during weekends complete with special vaccination card for identification while a house-to-house campaign will also take place in Pililla during weekdays.

In Laguna, the Provincial Health Office, led by Dr. Rene Bagamasbad, has started a catch-up immunization activity especially in affected communities and has coordinated with the DOH to prepare an Outbreak Response Immunization (ORI).

The Batangas Pro-

vincial Health Office has begun an information drive and encouraged parents to have their children vaccinated at the nearest city or municipal health units.

According to Myreen Valenzuela of the Batangas Provincial Disease Surveillance Office-Provincial Health Office, the age of children who can be given measles vaccines has been lowered from nine months to six months especially in Lipa City where the highest number of suspected cases were recorded.

In Cavite Province, the government will prioritize children six months to 59 months-old who have not yet been vaccinated according to Provincial Epidemiology Surveillance Unit and DOH Field Health Services Information System Coordinator Cristina Amulong.

In Lucena City, Quezon, the local government continuously conducts its vaccination activities in the villages according to Nurse III Elizabeth Caparos. Locally known as "tigdas," measles is a highly contagious virus that can spread through coughing and sneezing. It appears within 14 days after exposure to a person infected with the virus.

Symptoms include fever, dry cough, runny nose, red watery eyes, tiny white spots inside the mouth and skin rashes.

Janairo said there is no cure for measles but it can be prevented through proper immunization of children ages six months to 59 months old. (PIA4A pooled report, with reports from DOH-Calabarzon)
