More than 500 elementary and high school students who won medals for the Philippines in international math, science and English contests in 2018 were recognized at a ceremony.



# **HONTIVEROS TO DOH:** STUDY INCENTIVIZING VACCINATION

Amid reports that over 21,000 measles cases have been recorded across the country with 315 fatalities, Akbayan Senator Risa Hontiveros called on the Department of Health (DOH) to study the possibility of incentivizing its vaccination programs to motivate more Filipinos to get their recommended vaccines.

Hontiveros, who is the Vice-chair of the Senate Committee on Health, said that on top of the government's information drive, incentive rewards may be given in exchange for receiving a vaccination and returning for subsequent vaccination shots. She said that this could be in the form discounts and even tax cred-

Hontiveros cited Australia as an example. She explained that the Australian government provides financial incentives for parents to get kids vaccinated in the form of tax credits. Doctors, too, incentivized when children get vaccinations on sched-

As a result, in January 2016, more than 210,000 families had taken action to ensure that they comply with Australia's immunization programs.

"Libreng load para

Hontiveros said that telecommunication companies could also help in providing incentives as part of their corporate social responsibility.

"Aside from text message reminders, maybe the telcos can provide incentives in the form of 'libreng load' for families whose children have completed their vaccinations. Libreng pasa load para sa bakuna," Hontiveros said.

"While educating people about the benefits of vaccination is our top priority, these proposals are worth studying and exploring. As we double our efforts to increase our vaccination coverage, especially in urban poor localities and farflung areas where children are prone to preventable diseases, we must also be creative in employing new strategies," Hontiveros said.

"Forests and people are intertwined. Humans rely on forests for their basic needs: clean air, food, water, and raw materials for medicine, shelter and clothing." This was stressed by Dr. Theresa Mundita S. Lim, Executive Director of the ASEAN Centre for Biodiversity, on the occasion of the International Day of Forests on 21 March. The annual celebration emphasizes the importance of all types of forests and trees in the world.

Dr. Lim said beyond the basic needs, forests play an important role in development. Forests are key ecosystems that significantly contribute to the achievement of the United Nations Sustainable Development Goals, which are geared towards economic growth, social equity, and environmental protection.

Citing the ASEAN region as one of the world's fastest growing economies, the ASEAN biodiversity expert said the region's 200 million hectares of forest cover is one of its main development assets.

"Our forests abound with species that provide ecosystem services to support the region's growing population. They are home to millions of plant and animal species that serve as raw materials for businesses and industries. Forests also provide income as millions of ASEAN citizens rely on forest products for their livelihood. The ASEAN Biodiversity Outlook 2 reports that, on the average, export from forest products has been valued between USD 3.1 billion for fuel and timber products to USD 44.44 billion for plantation crops per year," Dr. Lim added."

She emphasized that economic development is threatened by climate change. "ASEAN's forest cover defends us from the detrimental effects of climate change as trees remove carbon dioxide from the air, store carbon, and release oxygen into the atmosphere. Tourism contributes to economic development. ASEAN's forests provide aesthetic natural beauty through the rich biodiversity, serving as favorite spots for tourism, inspiration and relaxation."

Dr. Lim cited ASEAN's response to conservation of biodiversity and forest ecosystems – the ASEAN Centre for Biodiversity's flagship programme called the ASEAN Heritage Parks (AHP) – which are protected areas of high conservation importance, preserving in total a complete spectrum of representative ecosystems of the ASEAN re-

The AHP Program, Dr. Lim said, aims to generate greater awareness, pride, appreciation, enjoyment and conservation of ASEAN's rich natural heritage, through a regional network of representative protected areas. The programme also aims to generate greater collaboration among the ASEAN Member States in conserving their shared

Of the 44 ASEAN Heritage Parks, majority are forests. Among the favorite AHPs for ecotourism are the Khao Yai National Park in Thailand, Mt. Makiling Forest Reserve in the Philippines, Bukit Timah Nature Reserve in Singapore and Kinabalu National Park in Malaysia.

The Tasek Merimbun AHP in Brunei Darussalam is a wildlife sanctuary, serving as home to a variety of flora and fauna. It also serves as recreational center and venue for research and education. The Virachey National Park in Cambodia is famous for sustainably managing natural and cultural resources in partnership with local communities. The Gunung Leuser National Park in Indonesia is particularly significant as it is the last place where orangutans, tigers, elephants, rhinoceros and leopards live together.

The Nam Ha National Protected Area in Lao PDR supports agricultural production and electricity generation generation Cavite Provincial Government's environment awareness campaign "Kalinga sa Kalikasan" went to Zapote 5 yesterday, with provincial and city officials encouraging Bacoorenos to do their part in keeping their surroundings clean. LUCENA CITY -To assure the public of fair and impartial investigation on the death of a Quezon mayor's son and bodyguard, the city police chief and three other policemen involved in the alleged shootout were ordered relieved from their posts.

Quezon police

director, Senior Supt.
Osmundo de Guzman
yesterday issued an order relieving Tayabas
City police director Supt.
Mark Joseph Laygo. He
was replaced by Supt.
Roderick Tonga.

Also relieved were PO3 Christopher John Siman, PO1 Perry Malabaguio and PO1 William Allan Ricamonte, all assigned at the Public Assistance Center who were involved in the alleged shootout that left Christian Gayeta, 21, son of Sariaya, Quezon Mayor Marcelo Gayeta and his body guard Christopher Manalo, 38, dead on Thursday morn-

ing at Bgy. Calumpang,

The relieved policemen were assigned at the Provincial Holding Administrative Section (PHAS) at the Quezon police provincial office headquarters.

But De Guzman

clarified that the relief of four policemen doesn't mean that they have committed wrongdoing in connection with the incident.

He said its only a preventive measure to pave the way for a thor-

ough investigation now being conducted by the Provincial Investigation and Detective Management under Chief Insp. William Angway.

"We will see to it that our investigators will be fair in handling the case", said De Guzman.


the Luang Namtha plain. At the Alaungdaw Kathapa National Park in Myanmar, the Buddhist monks have joined forces with authorities to educate over 100,000 pilgrims annually about wildlife. At the Kon Ka Kinh National Park in Viet Nam, local people depend on the park's resources for their firewood, honey and rattans. They also use at least 110 plant species with traditionally-known medicinal values. These are just some examples of how major forests in the ASEAN contribute to the overall development of the region.

Dr. Lim encouraged governments, the business sector, organizations and individuals to take action in promoting the conservation of forests, and making sure that they veer away from irresponsible practices and activities that threaten ASEAN's forest biodiversity and ecosystems. (ACB)


