promote road safety and raise awareness of the health impact and economic costs involved.



out around 9.7 million cards). So, there's no reason why we will not have enough cards for the entire year." Mendoza said.


"Dahil nga dito by July 1 of this year, dapat wala na pong backlog (Because of this, by July 1 of this year, there should be no more backlog)," he added.

In his video message, Go, who is an adopted son of CALA-BARZON, stressed the significance of implementing improved strategies to tackle livelihood concerns, ensuring a more inclusive economic recoverv

In line with this. Go filed Senate Bill No. 420, which aims to institutionalize a program that shirts, vitamins, and balls

offers employment to eligible individuals from underprivileged rural households. According to the proposed measure, the Rural Employment Assistance Program (REAP) would be established to provide temporary employment avenues for individuals meeting specific criteria, including economic hardship, poverty, displacement, or reliance on seasonal employment

Speaking from the window of the Apostolic Palace on May 12, Pope Francis asked the crowd gathered in St. Peter's Square for a round of applause to celebrate all mothers. "Mother's Day is celebrated in many countries today. We reflect with gratitude on all mothers, and let us also pray for mothers who have gone to heaven. We entrust mothers to the protection of Mary, our heavenly mother," the pope said.


