MANILA, (PIA) -- President Ferdinand R. Marcos Jr. on Monday announced the provision of additional free hemodialysis for many Filipinos who need the life-saving medical treatment.

The Chief of Police of Trece Martires City Police Station, PLTCOL JONATHAN A ASNAN, identified the suspect as Rolan Manzano y Bunag, 43 years old, and a resident of Belvedere Brgy Paradahan, Tanza Cavite wanted for the crime of Lascivious Conduct under Sec.5 (b) R.A. 7610.

After close monitoring and surveillance, Manzano was arrested by virtue of a Warrant of Arrest for the crime of Lascivious Conduct under Sec.5 (b) R.A. 7610 under Criminal Case No. DC-13750-22, issued by Regional Trial Court Branch 90, Dasmariñas City, Cavite.

OFW-dependent scholarship program

CITY, Laguna (PIA) -The Overseas Workers Welfare Administration (OWWA) in Calabarzon has urged gualified dependents of overseas Filipino workers (OFWs) in the region to avail of their scholarship program.

Avilina Sheryl Briton-Caya, OWWA 4A Programs for Education Coordinator, told the Philippine Information

CALAMBA Agency that they are now 'yung eligibility ng bata," accepting applications for the OFW Dependent Scholarship Program (ODSP) for the Academic Year 2023-2024.

"Wag na magpa-tumpik-tumpik pa, mag-apply na, kumpletuhin ang hinihingint, yun lang ang ipasa para maging eligible for scholarship and the rest of the requirements will be coordinated personally para ma-validate namin

Caya said.

Caya added that the OWWA4A opened 60 slots for incoming college students and another 65 slots for currently enrolled college students. She said the ODSP offers Php20,000.00 in educational assistance to qualified dependents of OFWs who receive a monthly salary of not more than US\$600.00. According to

Caya, applicants must be an immediate OFW family member who shall enroll or currently enrolled in any four-year or five-year baccalaureate course or associate course in any college or university to qualify for the scholarship program. "Unang-una

Meanwhile, the OWWA 4A also bared the list of 67 gualifiers for the Education for Development Scholarship Program (EDSP) and the Congressional Migrant Scholarship Workers Program (CMWSP).

Caya said the OWWA 4A maintained around 500 EDSP scholars who receive Php60,000.00 annually and 400 ODPS scholars who receive P20,000.00.

The deadline for the submission of requirements for the ODSP is on July 31, 2023. Caya advised

interested applicants to visit the OWWA 4A office and regularly monitor their official social media pages for further announcements.
