MANILA President Ferdinand R. Marcos Jr. has appointed Eduardo Año as the new National Security Adviser (NSA), Malacañang announced on Saturday.

Presidential Communications Office Secretary Cheloy Garafil confirmed Año's appointment after the oath-taking at the Palace on Saturday.

"Former DILG (Department of the Interior and Local Government) Secretary Eduardo Año took his oath before the President as the new National Security Adviser," Garafil said.

The 61-yearold Año replaced Clarita Carlos who assumed the NSA post in June 2022. Año, a member

of the Philippine Military Academy Class of 1983, is a veteran intelligence officer who also served as the chief-of-staff of the Armed Forces of the Philippines (December 2016 to October 2017) under the Duterte admin-

Two suspects nabbed for a shooting incident in Trece

Martires City, Cavite

Camp BGen Pantaleon Garcia, Imus City, Cavite- Police authorities nabbed two suspects for being involved in a shooting incident that transpired at Summer Homes Subdivision, Barangay Cabuco, Trece Martires City, Cavite last January 12, 2023 at 11:35 in the evening.

PCOL Christopher F Olazo, Provincial Director, identified the victim as Mel Aubray Mijares, a jeepney driver and a resident of Barangay Conchu, Trece Martires City, Cavite while the suspects were Ronald Marquez and Ariel Layam, and both residents of Barangay Conchu, Trece Martires City, Cavite.

According to the report, at about 11:15 in the evening of January 12, 2023, Mijares reminded Marquez and Layam of the existing curfew hours in the area, because of this a heated argument ensued among the trio and without apparent reason, the suspects shot the victim three (3) times in the chest. The suspects were arrested infront of Brgy. Hall of Brgy. Cabuco, Trece Martires City, Cavite during the dragnet operations. Mijares was brought to General Emilio Aguinaldo Hospital, Barangay Luciano, Trece Martires City for medical treatment but was pronounced dead on arrival by Dr. Joseph Dan Garcia, attending physician.

Police operatives recovered the following pieces of evidence from the suspects: one (1) Armscor caliber .9mm; two (2) magazines; 13 live ammunition; one (1) caliber .38 with five (5) live ammunition; small knife; three (3) empty shells; one (1) slug and motorcycle.

The suspects were apprised of their constitutional rights and are now under the custody of Trece Martires City Police Station.### (Cavite PIO)

DA to boost onion production in Calabarzon amid high prices




As onion prices remain steep, the Department of Agriculture (DA) in Calabarzon said it will ramp up local production of the high value crop in the region.
