O R D E R

This resolves the Motion for Reconsideration of Cavite Weekly Chronicle Publishing and Printing dated April 18, 2022 praying that upon inclusion of the word Publishing and Printing in the subsequent actual newspaper publication issues, be allowed to participate regularly in the weekly raffle of legal notices.

Records show that what is registered with the Department of Trade and Industry is Cavite Weekly Chronicle Publishing and Printing and not Cavite Weekly Chronicle which is the name used in the newspaper. In the Motion for Reconsideration filed by movant-publisher Emma R. Apanay, she stated that the newspaper has valid and existing registration with the Department of Trade and Industry but failed to include the words Publishing and Printing in the heading.

The newspaper Cavite Weekly Chronicle Publishing and Printing was duly accredited by this Court from January 26, 2021 to January 26, 2026 as it has complied with all the documentary requirements for accreditation provided in Section 3 of A.M. No 01-1-07-SC, Guidelines in the Accreditation of Newspaper and Periodicals and in the Distribution of Legal Notices and Advertisements for Publication:

- a. The application for accreditation shall include complete and accurate information of the title of the publication, name of the publisher, name of the Editor-in Chief, frequency of publication, address, telephone number of the principal office, total number of copies printed and month, date and year of first issue;
- b. The newspaper or periodical has its principal office in the address registered with the SEC or DTI;
- c. The newspaper or periodical which has its principal office in any of the cities or municipalities in a province may be accredited by any one or all of the Regional Trial Court Executive Judges in the province xxx.

In movant's Motion for Reconsideration, she declared that they will undertake to indicate the registered business name by including Publishing and Printing in their subsequent publications to conform to the registered name with Department of Trade and Industry.


Moreover, the name Cavite Weekly Chronicle Publishing and Printing was indicated in the editorial box and the error of not indicating the complete registered name of the newspaper in the heading is without intent to deceive, mislead or confused the public.



WHEREFORE, finding merit in the present Motion for Reconsideration, the Court hereby grants the same and vacates the Order dated March 25, 2022, and orders Cavite Weekly Chronicle Publishing and Printing be included in the raffle of legal notices in the City of Dasmariñas City, Cavite.
