## PBBM wants old school calendar back next year

MANILA -- President Ferdinand R. Marcos Jr. wants the return of the old school calendar as early as next school year to avoid cancellation of classes due to the extreme heat brought about by the El Niño phenomenon.

In an interview on the sidelines of the Government-Owned or -Controlled Corporations (GOCCs) Day in Pasay City on Monday, President Marcos said he has



already asked Vice President and Department of Education (DepEd) Secretary Sara Duterte to

provide a concrete plan on the shift to old school calendar.

“Well, of course, hiningi ko ‘yan sa DepEd and asked Inday Sara to give me already a concrete plan because mukha naman hindi na tayo kailangan maghintay pa. At mukha naman kailangan na at I don’t see any objections really from anyone,” President Marcos said.

### “SkillsUp: Training Course on Information, Education and Communication (IEC)



DA-ATI CALABARZON, thru the Information Services Section (ISS), opened the “SkillsUp: Training Course on Information, Education and Communication (IEC) Materials Development Using Online Graphic Design Platform (Beginner Level)” held at DA-ATI CALABARZON’s 4-H Hub in Trece Martires City, Cavite.

Thirty (30) agricultural extension workers (AEWs) in the region are expected to have their knowledge and skills increased in developing substantive and effective IEC materials that they will utilize in delivering more efficient information and technology services to their clientele.

DA-ATI CALABARZON’s Center Director Dr. Rolando V. Maningas graced the opening program and highlighted the role of IEC materials as a strategy to disseminate essential information and spread awareness, especially among farmers and fisherfolks.

The five-day training course will run until May 10, 2024, covering various topics such as elements and principles of graphic design using Canva, content development, basic photography, documentation of agri-fisheries, plus hands-on exercises and workshops.

### ATI centers beekeeping training on its economic value, equips 31 farmer leaders in CALABARZON

CAVITE Province – Highlighting the economic value of beekeeping, the Department of Agriculture bureau, Agricultural Training Institute (ATI) in CALABARZON, equipped 31 farmer leaders with practical knowledge and skills thru the capability training dubbed as “Honey to Money: Training on Beekeeping” held on April 30-May 2, 2024.

Rural Improvement Club (RIC) members, Magsasaka Siyentista (MS), and personnel from Learning Sites for Agriculture (LSA) completed the three-day training that encompassed visits to apiary sites of Profeta’s Integrated Farm (Tanza, Cavite) and Mai Kanlungan (Indang, Cavite), hands-on practice on beehive splitting and honey harvest, as well as lecture-workshops held at ATI CALABARZON Training Hall (Trece Martires City).

“Zero knowledge po ako sa beekeeping bago magsimula ang training, pero ngayon po marami po akong natutunan. Talagang ang beekeeping po ay p’wedeng pagkakitaan dahil madami [na products] ang p’wede pong magawa sa honey at sa hive ng stingless bee,” said one of the completers Jenalyn Mendoza from Adorres Farm.

The said training was facilitated by the Information Services Section (ISS), in collaboration with Cavite State University’s Bee Research, Innovation, Trade, and Extension (BRITE) Center. Dir. Michele Bono and

Dr. Dickson Dimero of BRITE Center served as resource persons.

Topics covered include bee experiences of the adopters, bee biology, introduction to stingless beekeeping, issues and concerns in bee-

keeping, common pests and diseases of the bees, economics of beekeeping, and bee product development and marketing strategies.

Beekeeping, or apiculture, has been seen as a sustainable

livelihood opportunity for farmers in both rural and urban areas – promising significant income from products derived from it such as honey, beeswax, propolis, and royal jelly.

### DOH reintroduces immunization campaign against polio

SAN MATEO, Rizal (PIA) – The Department of Health (DOH) kicks off its Chikiting Ligtas Immunization Campaign 2024 to mark the beginning of a comprehensive immunization effort for children against vaccine-preventable diseases (VPDs).

In the launching event held at the Jose F. Diaz Stadium in San Mateo on April 29, the Rizal Provincial Department of Health Office led by Dr. Voltaire Guadalupe, led the mass vaccination of children that marks the beginning of targeted vaccination scheduled from May 2024 until the end of June 2024 throughout the province.

The highlight of the campaign’s kickoff was the introduction of the bivalent Oral Polio Vaccine (bOPV) and Supplemental Immunization Activity (SIA). The bOPV, aimed at protecting children against poliovirus infection, involves administering weakened forms of poliovirus to stimulate the immune system and

generate protective antibodies without causing illness.

100 children and infants aged 0-59 months received immunization against polio during the event. Guadalupe expressed his appreciation to parents for adhering to their call to get routine immunizations against polio, measles, and rubella for their children aged 5 years and below.

Dr. Voltaire Guadalupe praised parents and stressed the importance of vaccinating children under 5 to protect against polio, measles, and rubella. He emphasized the urgent need to address vaccine misinformation and hesitancy. (Photo: MBIL/PIA – Rizal) He also highlighted the pressing need to combat vaccine misinformation and fear within the community.

Dr. Guadalupe emphasized, “We, the DOH and your government, are here to prevent you from getting sick,” urging collective action to counter false information

and apprehensions surrounding vaccination.

San Mateo Mayor Bartolome Rivera Jr., Vice Mayor Jaime Roxas, and Municipal Health Officer Dr. Nyl Jarem Amoroso expressed their support for the launching of the vaccination program.

Dr. Amoroso advocated for a community-driven approach to spreading awareness, urging neighbors to inform each other about the campaign and collaborate with municipal health workers for house-to-house visits to ensure comprehensive immunization coverage for children.

“If you know your neighbor has a child under 5 years old, please encourage them to get vaccinated. Our nurses will visit homes to administer medicine and vaccines. We need everyone’s support to ensure children are vaccinated. Let’s work together positively,” the health officer said.

# Breast cancer patients 'Z benefit' now up to P1.4M –PhilHealth

MANILA – The Philippine Health Insurance Corporation (PhilHealth) has increased its "Z benefit" package for breast cancer patients to PHP1.4 million.

In a news release on Tuesday, the state insurer said the enhanced Z benefit package now covers Stages 0 to 4 of breast cancer and even expanded the eligibility quali-

cations of members who can avail, even covering patients already undergoing treatment for the said illness.

"This significant leap in the Z Benefits Package for breast cancer is proof that PhilHealth is committed to delivering our mandate to provide responsive benefits to our Kababayans and we will continue implementing

benefits that will improve the financial coverage under our thrust Pinalawak at Bagong Benepisyo para sa Mamamayang Filipino", PhilHealth president and chief executive officer Emmanuel Ledesma Jr. said.

He said it provides "a 'holistic approach' to breast cancer treatment because it covers diagnostic tests, breast cancer

management up to surveillance or assessment for early signs of relapse after the surgery".

Diagnostic tests and prognostication range from PHP1,000 to PHP10,000; surgical procedures from partial mastectomy to modified radical mastectomy range from PHP30,000 to PHP140,000; hormonal therapy coverage is PHP2,700 or PHP 18,000 while cytotoxic chemotherapy shall be paid from PHP43,000 to PHP185,010.

The bulk of the package goes to targeted therapy amounting to more than PHP1 million coverage, which translates to PHP333,336 for 18 maximum cycles.

The surveillance, which is divided into basic and specific services, ranges from PHP5,000 and PHP9,000, respectively.

Contracted health facilities are those capable of rendering specialized care that enter into a contract with PhilHealth for the provision of specialized care for the Z benefits. (PNA)

# Nuclear energy key to addressing power woes – PNRI chief

MANILA – Nuclear energy could help in addressing power shortage in the country, the head of the Philippine Nuclear Research Institute (PNRI) said Tuesday.

In a Bagong Pilipinas Ngayon briefing, PNRI executive director Carlo Arcilla said nuclear has four million times more energy than gasoline.

Arcilla also said a nuclear power plant is available 90 percent of the time as it does not depend on the weather.

He cited as an example the Bataan Nuclear Power Plant which was built in the 1980s.

"There are power plants in Slovenia, South Korea and Brazil that

were also built during the 80s. They have been operating for 40 years," he said, adding that those are being relicensed for 20 years.

Arcilla noted that although it is expensive to build a power plant, it could last for about 80 years, making it cheaper in the long run.

"America for example has 94 operating nuclear power plants with an average age of 60 years," he said.

Those power plants supply 20 percent of the United States' energy, Arcilla added.

In terms of environmental concerns, he said nuclear power plants have zero emissions. Nuclear wastes, on the other hand, could be geologically buried at least 650 meters below the ground, wrap with a material called bentonite.

Arcilla said nuclear wastes could be brought to an isolated island and disposed of using borehole technology.

Doing so would make it safe, as if the nuclear waste didn't exist, he added.

Meanwhile, Arcilla said there are around 700 to 800 nuclear submarines globally and he has not heard of an accident involving those.

"Nuclear power has had a lot of experiential concerns, and people are not aware of it," he said.


The investment forum focused on marketing the produce that are ready to be harvested by participating farmers. DA said that the program aims to facilitate discussions among key agriculture stakeholders in the
