Eight barangays in Imus are certified drug-free

The Liga ng mga Barangay in Imus City, led by federation president AJ Sapitan, has given recognition to barangay (villages) that have been cleared from illegal drugs during Monday's regular flag raising rites at the city plaza.

The latest villages that received citations pursuant to the Regional Oversight Committee on Barangay Drug Clearing Pro-

gram Resolution 27 are Barangay Maharlika of Chairwoman Gina Hynson; Barangay Espeleta 3 of Chairman Teng Nato; Barangay Medicion 1A of Chairman Omar Camat and Barangay Medicion 1D of Chairwoman Antoinette Camerino.

A total of eight of 97 villages in the city were certified by LtCol. Gerald Sy Dee as drug free and attested by Imus Mayor Emmanuel

Maliksi and validated by Philippine Drug Enforcement Agency Regional Director Jigger Montallana. The other cleared villages are Barangay Poblacion 1 C, Barangay Poblacion 3 A, Barangay Tanzang Luma 6 and Barangay Bagong Silang.

and requirements that can be processed online. This ensures a smooth flow of updating the needed requirements per LGU, the moment it declares a "Restricted" travel policy. The LGUs can also verify the authenticity of documents, monitor and generate records of incoming travelers along with their travel histories that can be useful in facilitating close coordination among Provincial and City/Municipal LGUs.

The system can also help the Philippine National Police (PNP) guide residents going to other LGUs in applying for travel documents when needed; help the LGUs in monitoring travelers in their territories; and verify the authenticity of travel documents presented.

Also, Monitoring Agencies can easily monitor the travelers and generate a report at the municipal, provincial, regional, and national levels for monitoring and planning purposes.

For Region I, all provinces (Ilocos Norte, Ilocos Sur, La Union and Pangasinan) have already activated their S-PaSS accounts and updated their travel policies.

To fully maximize the features of the S-PaSS, DOST encourages travelers to register by logging in to <https://s-pass.ph> and register using personal mobile numbers. From there, the documents required by the LGU of destination and their

restrictions on travel can be viewed. For TCPs, it can be submitted through the website. Most LGUs have contact numbers for easy coordination and verification of the status of TCP approval. It is advisable that travelers apply 1-2 days before their trip as the duration of approval depends on the LGU and not the system itself.

As of 27 April 2021, there are already 646,638 registered users of the system nationwide, with 86,944 coming from Region I. More than half of the provinces in the Philippines, which amounts to 69% of the total number, now use the S-PaSS for their monitoring and border control.

The success of the smooth implementation of the system can be attributed to the responsible contribution and action of the travelers, the LGUs, the PNP, and monitoring agencies. With the collaboration of different organizations, more developments and innovations can be productively generated to steer the country into maximizing the advantages of science and technology for the people.

Batangas Identified as PAFES' Pilot Province in Calabarzon

TRECE MARTIRES CITY, Cavite – Batangas province has been selected as pilot province for the implementation of Province-led Agriculture and Fisheries Extension Systems (PAFES) in CALABARZON. PAFES is one of the flagship projects of the Department of Agriculture aimed to stimulate agricultural modernization in the Philippines.

The Department of Agriculture Regional Field Office IV-A organized the consultative meeting last May 17, 2021 which aims to level-off the knowledge of partner agencies and private organizations regarding the establishment of Province-led Agriculture and Fisheries Extension Systems in Batangas.

PAFES aims to showcase a model of strengthening research-extension-farmer-fisherfolk linkages in the Provinces by sharing science-based knowledge and innovations from State Universities and Colleges (SUCs), DA agencies and the private sector with farming and fishing, families, rural communities and agriculture enterprises.

In his message, Batangas Governor Hermilando Mandanas emphasized the importance of stakeholders' collaboration and pointed out that high-level activities should still be implemented by the national government. He also highlighted that there is a need to further strengthen the capacities of both the DA and the LGUs.

The activity was participated by national government agencies including the BFAR, ATI, PCA, PCC, PhilRice, SRA and the DA - RFO 4A, PLGU-Batangas, Batangas State University, various farmers' federations and cooperatives including financial institutions.

During the morning session, representatives from National Government Agencies presented their extension activities for Batangas province, while the afternoon discussions focused on the creation of PAFES. It was moderated by Dr. Rolando V. Maningas, OIC-Assistant Center Director of Agricultural Training Institute - Regional Training Center (ATI-RTC) in CALABARZON.

Dasma chess wizards to represent country in FIDE Chess World Cup

TRECE MARTIRES CITY, Cavite (PIA) -- Daniel Quizon and Michael Concio, Jr., two 16 year-old Grade 10 students of the Dasmariñas Integrated High School will represent the country in the FIDE World Cup chess tournament in Sochi, Russia on July 2021.
The chess athletes ranked top 2 in the recently concluded Asian Zonal 3.3 Chess Championships after winning against Indonesian Grand Masters who represented Indonesia in the Board 1 and 2 of the Chess Olympics.
During the last round of the championships, Quizon tied with Indonesian Grand Master Susanto Megaranto leading with 7 points - 5 wins and 4 draws while Michael Concio scored 6.5 points as he defeated Indonesian Grand Master Novendra Priasmoro in the last round in 103 moves.
The Asian Zonal 3.3 Chess Championship was held via online using the Tornelo platform where the boys played from the home of their coach FIDE Master Roel Abelgas.
Fourth District Representative Pidi Barzaga was proud and expressed support to the teen chess wizards.

FOR HASSLE-FREE TRAVEL, PASS THROUGH WITH DOST’S S-PASS

Make your travel easy and convenient during the quarantine period with the newly developed mobile application called Safe, Swift and Smart Passage or simply S-PaSS.
S-PaSS, launched on 26 March 2021, is an online system primarily intended to efficiently manage travels of Filipino local workers, Returning Overseas Filipinos (ROFS), local tourists, and others who need to go on business from one province to the other. It was developed by the Department of Science and Technology (DOST) Regional Office VI.

This app is utilized in two ways: as a Travel Management System which is a convenient online communication and coordination platform for travelers, Local Government Units, and other monitoring agencies, and as a Local Mobility Management System which replaces the use of pen-and-paper logbooks for visitors and personnel of public and private companies, schools, and other institutions or orgnizations.



For travelers, accessible information on the travel policies of all LGUs particularly when traveling by air and sea can be obtained. Usually, a health declaration form/medical certificate or a Travel Authority or both is needed for the traveler to pass through borders. Sometimes, it can be confusing to those who travel for work, vacation, or business as each LGU has their own list of guidelines. But with S-PaSS, the needed requirements can be identified easily. The travelers can be guided whether the area of destination is 'Restricted' or 'Unrestricted', which is duly updated by the LGUs responsible. If the LGU is on a 'Restricted' level, a 'Travel Coordination Permit (TCP)' should be applied, however, if the LGU is declared as 'Unrestricted', yet, the traveler needs to pass through 'Restricted' LGUs, a 'Travel Pass-Through Permit (TPP)' can be generated and presented. S-PaSS is to be used before and during actual travel.

In other words, the S-PaSS is a travel management system and nota contact tracing application that other local government units use.

For LGUs, this is beneficial in organizing and ensuring a systematic way of posting information about their travel policies

DOH SAYS ALMOST 4.5M FILIPINOS VACCINATED AS OF MAY 25

Among those who have been fully vaccinated, about 581,797 are health services front-liners, 195,952 are senior citizens, 250,777 are individuals with comorbidity, and 535 are essential sector front-liners.

"Most of those we've vaccinated, those in priority group A1, we're already at 85 percent, first dose who are master-listed, second are the senior citizens at 12 percent only so we need to

promote the A2 and A3 (groups)," Cabotaje said.

The highest number of jabs administered on a single day was 238,888 on May 21 due to the increased supply of the AstraZeneca Covid-19 vaccine, she

said.
