8,000 tree seedlings, bamboo stalks set for planting in Calabarzon

SAN MATEO, Rizal - Government agencies will partner with civil society organizations and other volunteers in planting more than 8,000 tree seedlings and bamboo stalks in different sites in the Calabarzon region on Tuesday, Sept. 13, the Department of Environment and Natural Resources (DENR) said.



The DENR-Calabarzon said the event serves as the kick-off ceremony for the nationwide simultaneous tree planting activity by the Department of the Interior and Local Govern-

ment (DILG) in collaboration with the Department of Agriculture and DENR.

Executive Director Nilo Tamoria earlier visited the former 70-hectare sanitary landfill at Baran-

the firm commitment of the Department of Social Welfare and Development (DSWD) to bring social services directly to the communities, led the groundbreaking ceremony of the proposed building, facilities, and other amenities of DSWD Field Office-CALABARZON last September 2.

The 4-storey office building of Field Office IV-A will be constructed at Barangay Marawoy in Lipa City, Batangas, along with a 2-level warehouse facility, 3-storey supply and record building, 4-storey learning center, multi-purpose building, and a 2-storey motor pool with office room. The building designs were drafter by the Department of Public Works and Highway (DPWH).

Secretary Tulfo emphasized that the construction of the PHP 543.1 million-infrastructure project is another milestone for the Department as it continues to improve the delivery of its services, programs, and other interventions to

"With the ever-changing landscape of social work, as well as with the evolving crisis situations such as disasters and calamities in the country, it is significant that we continue to innovate ways and create spaces to bring the social welfare programs and services closer to our beneficiaries," he added.

The Secretary also expressed his gratitude to Congressman Ralph Recto for his unwavering support for the transfer of the DSWD office; the local government unit (LGU) of Lipa City and the province of Batangas for the site and donated lot; and to other partner-government agencies which pushed for the realization of the project.

After the groundbreaking ceremony, Secretary Tulfo and Mayor Eric Africa signed a Memorandum of Agreement. As part of the partnership, a Usufruct Agreement was forged while the Deed of Exchange was facilitated by Lipa LGU and DA to rightfully allow the Department to utilize the site for the construction of its offices and eventually the Department of Agriculture (DA) will prepare the Deed of Donation transferring the ownership of the said lot

The MOA signifies the support of the concerned officials and offices in the 5-year implementation plan of the project. Congressman Recto, Batangas Governor Hermilando Mandanas, Engr. Jovel Mendoza of DPWH and OIC-Regional Director Fidel Libao of DA served as witnesses to the ceremonial signing.

Eala, who improved her junior ranking to No. 167, said she learned a lot about herself during the competition.

"I am very happy with the way I handled each and every point. I had a lot of moments in this tournament where I was down, and I could have lost a set and could have gotten mad easily but I didn't. I think my behavior throughout the whole week was something I can be proud of," said the bringing home another honor to the country. 5-foot-9 Eala, who is based at the Rafa Nadal Tennis Academy in Mallorca. Spain for the past four years.

To reach the final, she beat No. 8 Australian Taylah Preston, 6-2, 7-6 (7-1); No. 14 Russian Mirra Andreeva, 6-4. 6-0; and No. 9 Canadian Victoria Mboko, 6-1, 7-6 (7-5).

Eala now has three iunior Grand Slam titles, including the two doubles coming from the 2021 French Open with Russian Oksana Selekhmeteva and the 2020 Australian Open with Indonesian Priska Madelyn Nugroho. She had a career-high ranking of No. 2 in October 2020 following a semifinal appearance at the French Open girls' singles.

As a pro, Eala is currently No. 297 in the WTA rankings. This year, she won her first ITF W25 title in Chiang Rai, long ng ating pagtatanim Thailand and was a losing finalist at the ITF W60 event in Madrid to reach a career-high of No. 280 in July.

Eala debuted at the 2019 Southeast Asian Games held in the Philippines, winning the bronze medals in women's singles, women's team event and mixed doubles with Filipino-American Treat Conrad Huey.

On the occasion of the 65th birthday of President Ferdinand "Bongbong" Marcos Jr., state pension fund Government Service Insurance System (GSIS) President and General Manager Wick Veloso announced today that the pension fund will honor the top 65 government agencies that have been religiously and accurately paying GSIS premiums and loan payments on time and complying with the other requirements of GSIS.

"These exemplary agencies help our lingkod-bayan enjoy the hard-earned benefits they deserve for devoting the best years of their lives in serving our government. We all know that loan balances, if left unpaid, would balloon to unmanageable amounts. This will diminish members' benefits and leave them with little or no proceeds at all when they retire or separate from the service," GSIS president and general manager Wick Veloso

Under the law, all government agencies must remit to GSIS the contributions and loan amortizations of their employees within the first 10 days of the calendar month following the month to which the contributions apply. They must also deduct the loan amortizations from the monthly compensation of their employees. GSIS has roughly 7,000
