# New CALAX interchange to open 2022

*Trece Martires City, Cavite (PIA) - The Cavite-Laguna Expressway (CALAX) is set to make a major milestone this year, as it eyes the operationalization of its upcoming Silang (Aguinaldo) Interchange to extend CALAX's operational sections from Mamlasan, Laguna, to Aguinaldo Highway in Silang, Cavite.*

As of date, the 3.9-kilometer 2x2 lane CALAX subsection reaches 56% of completion. Part of the ongoing works includes drainage and bridge constructions, excavation and roadway earth-works, and installation of fence and coco net.

"The Silang (Aguinaldo) Interchange will help decongest the busiest highway in the province of Cavite — the 41-kilometer Emilio Aguinaldo Highway. Motorists from Manila going to the famous tourist destinations of Silang and Tagaytay, Cavite will surely benefit from this upcoming project as it offers convenience and shorter travel time," said Mr. Raul L. Ignacio, President and General Manager of MPCALA Holdings Incorporation (MHI).

Sa kabila nito, siniguro ng alkalde na nakaalerto ang kanilang bayan laban sa mga sakit na posibleng kumalat ngayong panahon ng tag-ulan, kabilang na ang dengue.

# Space Science Camp set on July 19-21

MANILA -- To raise awareness on space science and technology, a Space Science Camp will be organized by the Philippine Space Agency (PhilSA) from July 19 to 21 virtually and in Quezon City on the second day.

"This event aims to raise awareness and interest in space science and technology. The camp also aims to inspire and empower the younger generation to pursue further studies related to Space Science Technology & Applications (SSTA)," one of the project leaders, James Cesar Refran, told the Philippine News Agency on Friday.

Refrán said that due to the pandemic restrictions, the PhilSA has decided to conduct the camp this year as a pilot program, and prepare for a bigger camp next year.

For 2022, incoming senior high school (SHS) learners, campus journalists, and educators from science high schools from the 16 division schools of Metro Manila have been invited to the three-day camp, he said.

According to the PhilSA, 32 SHS students and 16 teachers will be attending the camp.

PhilSA has partnered with the Department of Education (DepEd), Department of Science and Technology - Science Education Institute (DOST-SEI), Moon Village Association (MVA), and the University of the Philippines National Institute for Science and Mathematics

contest and a moon viewing lecture and activity are also scheduled.

SSTA career opportunities, activities to highlight the relevance of space to everyday life, and an introduction to space missions and satellite payloads will be tackled virtually on Day 1.

in the Malabon-Navotas-Tullahan-Tinajeros River System from 3.7 billion MPN/100mL to 4.8 million MPN/100mL, as well as in the waters near the Navotas Fishport from 920,000 MP-N/100mL to 9,200 MP-N/100mL.

“We have seen remarkable gains in Manila Bay based on the water quality monitoring results. Rest assured that we will not stop here and will continue our work as part of the Manila Bay rehabilitation project,” Michael Drake Matias, EMB-NCR regional director, said in a news release recently.

Although the readings show that the current levels are still far from the fecal coliform standard of 100 MPN/100mL to restore Manila Bay’s water quality to Class SB level, Matias said the goal is a big challenge but attainable through the collaboration of both local and national governments and the public.

Class SB is a DENR classification for coastal areas and waters where the public may safely engage in bathing, swimming, skin diving, and similar recreational activities.

“Reaching the 100 MPN/100mL standard is not impossible through our solid waste management strategies, geoengineering interventions, and with the establishment of our real-time online water quality monitoring system,” Matias said.

The interchange is 16 kilometers away from the city proper of Tagaytay via Aguinaldo Highway, and the travel time is around 20 minutes only.

Other interchanges of CALAX namely Open Canal, Governor's Drive, and Kawit are targeted to be completed by 2023. Currently, CALAX's operational segment spans 14.24-kilometer with interchanges at Greenfield-Mamplasan, Laguna Technopark, Laguna Boulevard, Santa Rosa-Tagaytay, and Silang East. Upon completion of the entire CALAX project, it will connect to the Manila-Cavite Expressway (CAVITEX) in Kawit, Cavite.

CALAX is a 45-kilometer expressway, a Public-Private Partnership (PPP) with the Department of Public Works and Highways (DPWH) as implementing agency, and with private proponent MPCALA Holdings Inc. (MHI), a subsidiary of Metro Pacific Tollways Corporation (MPTC), and the toll road development arm of Metro Pacific Investment Corporation (MPIC). (RBF/PIA-Cavite with reports from MPT South)

# DENR cites significant improvement in Manila Bay water quality

The Department of Environment and Natural Resources (DENR), through the Environmental Management Bureau - National Capital Region (EMB-NCR), has observed a significant improvement in the wa-

ter quality of Manila Bay, which it attributed to the continuing rehabilitation efforts in river systems and tributaries.

Based on the data of the EMB-NCR as of June, the fecal coliform level at the Manila

Bay beach nourishment station near the United States Embassy has decreased to 2,400 most probable number per 100 milliliters (MPN/100mL), down from 7,100 MPN/100mL in 2021.

Two water qual-

ity monitoring stations near the Dolomite Beach also registered lower fecal coliform levels – from 7,300 MPN/100mL to 1,700 MPN/100mL, and from 10,200 MPN/100mL to 2,100 MPN/100mL, respectively.

The four Metropolitan Environment Offices likewise reported a significant decrease in fecal coliform levels within their respective areas.
