



Marcos admin says no need for ICC to step in on PH's handling of Duterte's drug war issue

MANILA -- The Marcos administration said the International Criminal Court (ICC) should let the Philippines resolve the Duterte administration's war on drugs issue under the country's well-functioning justice system, which enables it to hold the perpetrators accountable, a Department of Justice (DOJ) official said on Saturday.

The ICC has authorized Special Prosecutor Karim Khan to resume the investigation into the reported killings in line with the drug war of former President Rodrigo Duterte.

In a media forum Saturday Jan 28, Justice **Assistant Secretary Mico** Clavano said that the DOJ did not welcome the decision to authorize the resumption of the investigation because the Philippines has a working justice system and has the ability to prosecute those who are accountable.

Under international law, Clavano said, complementarity principle is observed, which means that the ICC, or any international court can only come in if a particular country doesn't have Cont.on PAGE 5
