# National Library holds 2nd Librarian's Convention

participating librarians in attendance, the National Library of the Philippines (NLP) opens the 2nd Convention of Provincial Librarians in the Philippines and Leadership Training-Workshop held Wednesday (Aug. 14) at the NLP Building in Kalaw, Manila.

Philippine Informa-

tion Agency (PIA) Director-General Harold E. Clavite who spoke during the event cited the importance of revitalizing Republic Act 7743, which seeks to establish congressional, city, and municipal libraries and barangay reading centers throughout the Philippines.

"Through the help of this law, libraries and learning hubs will be more accessible to the public," Clavite said.

"In assistance to NLP, the PIA will continue to promote the importance of libraries as one of the most credible repositories of information and knowledge," Clavite added.

Organized through the Public Libraries Division of the NLP, the three day training workshop is intended to equip librarians with the necessary problem-solving and leadership skills to better lead their respective insti-

**Assistant Secretary** for Plans and Programs Francisco R. Cruz of the Department of Interior and Local Government (DILG) cited the

importance of libraries and other learning institutions in achieving the goals of Ambisyon Natin 2014 which aims to lay a strong foundation for inclusive growth, a high-trust society, and a globally-competitive economy toward "Matatag, Maginhawa, at Panatag na Buhay para sa Lahat."

# **OFW** deployment in HK, normal - DOLE

MANILA -- The deployment of workers to Hong Kong continues despite the mounting protests and civil disturbance in the semi-autonomous Chinese territory.

Labor Secretary Silvestre Bello III said the labor department is yet to receive a recommendation from the Department of Foreign Affairs (DFA) if the condition would warrant a temporary deployment ban, even as the Philippine Overseas Labor Office (POLO) is closely monitoring the situation.

"The DFA has not yet raised the alert level in Hong Kong. We are waiting for their recommendation

before we make any action or temporarily suspend the deployment of our OFWs in Hong Kong," Bello said during a media forum in Malate.

He also directed the labor officials in Hong Kong to provide him with pe riodic report on the situation and should tension escalates.

The labor chief however advised OFWs to stay indoors and avoid going to areas where protests and tensions were concen-

# **Health Secretary Duque meets with Mayors of Cavite Province for Dengue**

General Trias, CAVITE,- Health Secretary Francisco T. Duque, III recently conducted a meeting with various mayors of Cavite province to ensure that preparedness and outbreak response against dengue are in place in all levels of care to support communities with dengue cases held at the Cavite Collaboration Center for Public Health

"Dapat lahat ng ating mga lokal na pamahalaan ay handa na makapagbigay ng suporta sa mga biktima ng dengue lalo na ngayong patuloy na tunataas ang mga kaso dito sa Cavite kailangan natin ng dobleng pag-iingat," he

"Magtulungan po tayo upang malutas natin at mapababa ang bilang ng mga nabibiktima ng dengue sa ating mga bayan at mailigtas sa tiyak na kapahamakan ang ating mga kababayan,"he added.

Duque also encouraged LGUs to establish hydration station in all rural health units for those suffering for high fever to prevent them from dehydration.

According to the Provincial Epidemiology and Surveillance Unit (PESU), there were a total of 6,232 dengue cases recorded from January 1, 2019 to August 5, 2019 with 27 deaths. This year's figure is 99% higher compared to the same period last year with 3,127 cases.

Ages of cases range from 1 month to 92 years old with males having the majority of cases at 53%.

Among the top five municipality/city with the most number of cases is Dasmarinas with 1,542 cases followed by General Trias with 575 cases; Bacoor with 510 cases; Imus - 507; and Silang - 475.

Duque also made his rounds at the dengue wards of the General Emilio T. Aguinaldo Memorial Hospital to check on the health status of patients.

On July 18, 2019, the provincial government of Cavite put the province under "state of calamaity" due to the rising cases of dengue. (DOH IV-A)

# President Duterte wants more police units to fight terrorists, communists

expanding influence of the Islamic State of Iraq Syria, (ISIS), President Rodrigo Roa Duterte wants the Philippine National Police (PNP) to establish additional counterterrorism units to make communities more secure.

US authorities reported the resurgence of ISIS in Syria following the defeat SAF [Special Action of the caliphate in the Middle East. It is feared that foreign fighters who have fought along with ISIS will return to their home countries to spread radicalism and launch terror attacks.

"I may just also remind you that we are facing so many fronts. I need more soldiers. I would need about...an additional of seven to 10

Force] troopers," President Duterte said in a speech during the oath taking of star rank PNP officers in Malacañang on Thursday.

"Kasi palaki nang palaki ang problema. We thought all the while that it would somehow wane...medyo hihina na. Apparently, with the migration...a lot of ISIS leaders in the Southeast Asia, we will have terrorism. tinatakutan ko 'yung ginagawa nila."

He suggested that the PNP, under Police Gen. Oscar Albayalde, should start the project immediately.

"I need about 10 Kayong talagang...talagang gasgasin ninyo nang husto 'yung sundalo para we can meet the coming dangers ahead," he said, highlighting the necessity of organizing more police units.

Members of the New People's Army are also threat to the country's security, according to the President. He reported, however, about the interest of the NPA's top echelons for a renewed talks with the government following an impasse.

"I don't know but they are insisting on resuming the talks and

'yung iba, I will not mention the name, they want to come home to talk. Sabi ko okay lang," the President said. The communist leaders are Luis Jalandoni and Fidel Agcaoili.

Closer community relations

Witnessing the reaffirmation commitment to service of the 38 newly promoted star rank officers of the PNP, the President urged them to rekindle their pledges as civil servants and protectors of the people as they take bigger responsibilities.

He encouraged the new police officers to foster improved relations

with the communities they serve to inspire the people to actively participate in nation-

building.
"I urge you to uphold the highest ethical standards in your profession even as you strive to remain firm in controlling order and the rule of law, preventing and controlling again crimes, and the order of our nation," President Duterte told the new star rank police officers.

"More than ever, we need our uniformed personnel to go beyond reproach and filled with dedication as we push for genuine and lasting reforms in government, he added.

President Duterte likewise asked them to become remarkable officers who would motivate the youth their upright example while reassuring them that administration fully supports the PNP's vision to become a highly capable, effective, and credible police force.

At the same time, the President recognized PNP's efforts to improve its capability, asking its members to work with his administration in the crucial task of eradicating criminality and corruption in the country.

Also present during the event were Interior and Local Government Secretary Eduardo Año and PNP Chief Police Gen. Oscar Albayalde.

Meanwhile. President Duterte raised

# POE NIXES ATM FEE HIKE: POOR TO BEAR BRUNT ANEW

Sen. Grace Poe vowed to immediately look into the plan to increase the fees for automated teller machine (ATM) transactions, saying it would further burden the hard-up Filipino workers.

Poe, chair of the Committee on Banks, Financial Institutions and Currencies, said the panel is prepared to conduct a public hearing on the matter upon referral of measures to the committee, including Senate Resolution No. 96, which she filed.

"Maliit na nga ang interes sa savings, pero ang laki naman ng kaltas mula sa balance inquiry hanggang sa withdrawal," Poe said.

"Kung tutuusin, para tayong nagpapahiram ng pera sa bangko kapag itinatabi natin ito sa ATM. Kung nagwi-withdraw tayo, kinukuha lang natin kung ano ang atin. "Bakit ang laki ng kaltas sa bawat transaction, tapos may hiling pang dagdag ngayon? she asked.

Reports have said that several banks have applied for higher ATM fees, between 36% to 50%, after the Bangko Sentral ng Pilipinas (BSP) lifted the moratorium on ATM fee increases.

Regardless of the amount, Poe said in her resolution that an increase in harge is "disadvantageous to an estimated 4.1 million minimum-wage earners who would need to carry the burden of these fees as many of them receive their salaries through ATM cards and withdraw from these machines at least twice a

"The practice of imposing hefty bank fees, including ATM charges is financially disadvantageous to our country's more than 58 million ATM cardholders," she

Currently, bank charges range from P10 to P15 for interbank withdrawals and P2 for interbank balance inquiry.

Poe said she wants to know how much banks collect from these charges and why the customers are being made to shoulder the cost of what should be part

She said she would also ask the BSP about its next course of action after the moratorium on ATM fees lapsed.

# **Bacoor City closes 21 market stalls in clearing ops**

BACOOR CITY, Cavite -- The city government on Thursday ordered the closure of 21 stalls at the Zapote Public Market.

During the clearing operation, a team from the city's Business and Licensing Office inspected the stalls and discovered many of them have no business permits.

Mayor Lani Mercado-Revilla immediately ordered the stores' closure as part of her directive for the Task Force Clearing Operations to intensify clean-up of roads from obstructions, illegal structures and sidewalk vendors.

In Noveleta town, Mayor Dino Reyes Chua led the clearing of public roads and obstructions including "eyesores" from illegal structures breaching the Barangay San Jose Dos.

He also reiterated instructions to remove the electric posts along the San Rafael National Road.

"I am requesting the help of the Cavite DPWH (Department of Public Works and Highways) and Meralco to help us remove all the electric posts that are obstructing along public roads after the road-widening project," Chua appealed.

In nearby General Trias City, Liga ng mga Barangays (LnB-village league) Federation president Alfred Ching of Barangay Dulongbayan, steered the league of 33 villages to clear their sidewalks from obstructions.

Ching, in his meeting with Mayor Antonio Ferrer and concerned city officials, said they have embarked on city-wide cleanup operations, including talks with owners to remove their illegally-parked vehicles on public roads.

The village chiefs also requested scores of property and business owners to remove illegal structures and debris or materials

that obstruct along roads and highways and public pathways especially in public convergence zones.

Ferrer led city officials, with Philippine National Police (PNP), Bureau of Fire Protection (BFP) and barangay leaders in removing road obstructions along Tejero crossing road, in the city proper, Governor Ferrer from Prinza-Sta. Clara crossing to Manggahan, Manggahan-Governor's Drive crossing to Crisanto delos Reyes Avenue, up to Panungyanan upland areas.

"What is pleasing to note is that the business owners themselves have the initiative to clean their respective areas and are clearing obstructions on sidewalks and streets," Ferrer said in Filipino.

The city mayor, however, warned that violators of the order will be meted out the corresponding penalty or revocation of business permits.

He said the city government is complying with President Duterte's directive and Department of the Interior and Local Government (DILG) Memorandum Circular 2019-121 issued on July 29 ordering all local government units (LGUs) to clear public roads being used by individuals or entities.

The DILG memorandum ordered local officials to exercise their powers to revoke permits that give private entities authority to use parts of any public roads. (PNA)

The local government of Silang led by Mayor Corrie Poblete hosted an outreach activity on August 13, 2019 at Patio Medina, providing basic healthcare services and other forms of assistance to the public including mobile NBI clearance, insurance, telecommunication and electric providers. On behalf of more than 500 beneficiaries of the medical and dental mission sponsored by Governor Jonvic Remulla, Mayor Corrie thanked volunteers from the Provincial Health Office, the Silang Dental Circle, and the Rotary Club of Acropolis for the constant support. Aside from the health mission, Silangeños also benefited from free-of-charge services on fluoride application to daycare students, derma and eye check-up, manicure, pedicure, haircut and massage therapy. The whole-day event which coincided with the birthday celebration of former Silang Mayor Areng Poblete was jam-packed with helpful activities that the locals will look forward to every year.

sharing culture and collaborative knowledge management among their fellow LGU and societal organizations." Cruz said while sharing the DILG's efforts in establishing libraries nationwide.

The DILG, pursuant to Section 17 (b) (1) of the Local Government Code of 1991 and DILG Memorandum Circular No. 99-208, urged local government officials to establish barangay reading centers that would be linked to the country's first public e-library.

Based on the Memorandum Circular, the LGUs should provide the barangays with innovative education tools through the e-library (www.elib.gov.ph).

The e-library has access to the union catalogues of the National Library, University of the Philippines, Department of Sci-

ence and Technology, Department of Agriculture, and Commission on Higher Education.

E-library also includes Filipiniana materials, theses, dissertations, researches, on-line resources, and subscription to electronic databases.

Barangay folks, especially the students, can have the access to the most comprehensive libraries in the Philippines and the world with more than 8,000 records consisting of Philippine materials and 29,000 full-text journals.

NLP Director Cesar Guilbert Q. Adriano said 2ND Convention of Provincial Librarians in the Philippines and Leadership Training-Workshop is very timely as it coincided with the 132nd founding anniversary of the National Library. (PIA InfoComm)




