# Sen. Go team holds relief effort to a total of 1,633 residents in Noveleta and Rosario, Cavite

A day after assisting residents in Cavite City and Kawit, the Office of Senator Christopher "Bong" Go oversaw another relief operation in Cavite on Tuesday, November 16, this time for the benefit of residents in

Noveleta and Rosario.

Go's outreach team distributed meals and masks to a total of 1,633 residents at the Noveleta Elementary School and Rosario National High School. They gave selected residents

new pairs of shoes and bicycles for commuting and computer tablets for children's use while studying at home.

Meanwhile, personnel from the Department of Social Welfare and Development also

provided financial assistance as part of an ongoing effort to assist individuals in crisis situations.

In a video message at the activities, the senator strongly reminded low-income households to get vaccinated

against the COVID-19 virus, noting that only 16% of the 4.17 million Pantawid Pamilyang Pilipino Program's active beneficiaries have had their shots as of 29 October 2021.

ment of Surgery and the Southern Tagalog Regional Hospital.

Janairo added that the facility's operational fund will come from the Annual Municipal Health Budget, Philhealth Capitation Fund, Income from E-konsulta, Pharmacy and Laboratory services.

He also assured that the regional office will provide the initial investment capital funds, health human resources including medicines, medical supplies and other health commodities.

DOH-CALABARZON Regional Director Eduardo C. Janairo assures the local government of Ibaan and various stakeholders that the regional office will continue to provide assistance to the super health center until all medical services are established and health equipment are provided.

He urged the government to approve the proposal to grant incentives to fully-vaccinated 4Ps beneficiaries in order to encourage the vaccine uptake and improve the immunity level of the poorest of the poor.
