## National summit on early pregnancy kicks off August 22

Following the directives of the President Rodrigo Roa Duterte, the Department of Education (DepEd)-Office of the Secretary (OSEC) and Bureau of Learner Support Services (BLSS), and the Department of Health (DOH), shall convene a summit to discuss and understand the education, health, and development dimensions

of early pregnancy in forging multi-stakeholder consensus on ways forward.

To be carried out in cooperation with the National Economic Development Authority (NEDA); Department of Social Welfare and Development (DSWD); Philippine Statistics Authority (PSA); United Nations Population Fund (UNFPA); and Philippine Educational

Theater Association (PETA), which form part of the steering committee, the summit entitled "Kapit-kamay: Empowering the Youth to Make Informed Choices" shall take place on August 22, 2019 at the Philippine International Convention Center (PICC) in Pasay City.

## DepEd Dasmariñas signs MOU with Greenpeace, regulates single-use plastic in schools

Dasmariñas City – The Department of Education City Schools Division of Dasmariñas and Greenpeace Southeast Asia Environmental Trust, Inc signed a Memorandum of Understanding, committing to a partnership which seek to champion the Youth

Formation Program particularly on environmental advocacy, July 26.

Responding to the call of promoting environmental awareness and action among the youth, Dasmariñas City is the first DepEd Division to initiate a policy on regulating the use of single-use plastic in all schools and offices in the city. Through Division Order No. 1, s. 2019, all students and teachers are directed to refrain from using disposable plastic containers including single-use plastic bottles/cups, plastic bags/

cellophanes, polystyrene containers (Styrofoam), and other plastic materials. The Supreme Pupil Government/ Supreme Student Government and Youth for Environment in Schools Organization (YES-O) took the lead in monitoring the implementation of the said policy.

Greenpeace shall work with DepEd Dasmariñas to support the Division in its environment-focused programs and projects and promote the #breakfreefromplastic campaign. The partnership shall ...Page 5

# Symposium for social and political awareness on hemophilia conducted

**T R E C E MARTIRES CITY, Cavite(PIA)** – The first Hemophilia Awareness Symposium for social and political awareness was conducted in the province by the provincial government's Provincial Health Office (PHO) at the Cavite Collaboration Center for Public Health Auditorium here.

PHO Epidemiologist Dr. Nelson Soriano stressed the importance of

having a Hemophilia Treatment Directory with identification cards of PWH (people with hemophilia) to be presented to healthcare providers in availing medical and dental services. He was quoted as saying: "Education is still the key along with proper information dissemination," in order to address this condition and expressed the hope that hemophilia be included in the Universal Health Care Bill.

Hemophilia, a genetically-inherited bleeding disorder in which the person's blood does not clot normally, remains unfamiliar to many Filipinos with about 10,000 Filipinos suffering from the disorder and only 1,500 have been registered with the Philippine Hemophilia Foundation, 28 of which are from Cavite.

The obvious unawareness about this condition by the public even by hospital personnel prompted the members of Hemophilia Advocates Philippines (HAP) to coordinate with the PHO and organize this event with the primary aim to raise social and political awareness for them to lobby their advocacy and seek legisla-

tionary measures that will address the hemophilia medical condition.

Pediatric hematologist from the Korean-Philippines Friendship Hospital and hemophilia advocate Dr. Melissa Montoya shared some knowledge on pediatric bleeding disorder and tips to manage cases in children such as the application of RICE which stands for Rest, Ice Packs, Compress and Elevate.

Dr. Montoya also revealed that, "I have recommended to the Department of Health (DOH) for the allocation of Factor 8 concentrate to the Gen. Emilio Aguinaldo Memorial Hospital (GEAMH)," and this gave much hope to PWH since

only a number of hospitals could handle patients with bleeding disorders.

Likewise, Social Welfare Officer III Brendalyn Salazar of PSWDO enlightened the members of the PWH with the simple procedures and requirements on seeking financial and medical assistance including requests for wheelchairs from the Office of the Provincial Governor.

She also assured them with their support stating, "Our office will lobby for the inclusion of PWH patients in the special cases like chemotherapy and dialysis patients qualified to receive financial assistance from the provincial government on a regular term."

The event was attended by medical practitioners, city and municipal health officers, doctors and dentists from public hospitals, nurses from the rural health units, members of the PWD federation, employees of the provincial government's Provincial Health Office, Provincial Social Welfare and Development Office, Provincial Information and Community Affairs Department, and members of HAP. months or more but not exceeding 24 months at a preferred interest rate of 6 percent per annum.

The veteran senator believes that this loan will help defray the living expenses of OFWs and their families during the first few months of their employment as well as other expenses incurred during pre-employment.

Data from the Philippine Statistics Authority (PSA) revealed that there are 2.3 million

overseas Filipinos who sent a total of P 235.9 billion in remittances. These remittances were divided into three types: cash sent home (P 169.4 billion), cash brought home (P 55.2 billion), and remittance in kind (P 11.2 billion).

PSA also stated that 96.2 percent of OFWs have existing work contracts during the period April to September 2018, while 3.8 percent worked overseas without contract.

## ON CORY'S 10TH DEATH ANNIVERSARY *Kiko calls to resist historical revisionism*

MANILA -- Honor the memory of President Cory Aquino by resisting historical revisionism, said Senator Francis "Kiko" Pangilinan on her 10th death anniversary today, August 1.

"Sa salita ngayon, lodi ng demokrasya si si Pangulong Cory. Inspirasyon siya di lang sa

Pilipinas. Pilipinas ang nagpauso ng mapayapang people power sa buong mundo(We remember President Cory as the shining icon of democracy. She has inspired not only Filipinos. The Philippines started the trend of peaceful people power for the whole world)," he said.

"Simbolo siya ng tagumpay ng bayan sa pakikibaka laban sa diktadurya. Ito'y isang aral na hindi dapat kalimutan, lalo na ngayon (She symbolizes the people's triumph in the hard-fought struggle against the dictatorship. It's a lesson that should never be forgotten, especially now)," Pangilinan said.

The senator, a student activist during martial law who credits this experience for his political awakening, noted the current barrage of historical misrepresentation especially in digital media.

"Ginagamit na sandata ng mga kaaway ng kalayaan ang digital media para ikalat ang propagandang binubura itong tagumpay ng demokrasya. Ipinanalo natin ang ating kalayaan sa EDSA. Dapat nating protektahan ang ating kalayaan at ang ating kasaysayan laban sa rebisyunismo (The enemies of freedom have weaponized digital media to spread the propaganda erasing this triumph of democracy. We won our freedom in EDSA. We must protect our freedom and our history against revisionism)," Pangilinan said.

A regular teenager in 1983, Pangilinan recalled that the assassination of Cory's husband, former Sena

Ayon kay Duque ang bilang ng kaso ng dengue 98% na mas mataas kumpara sa nakaraang taon sa parehong panahon. Sa bilang na ito ay mayroong 622 na mga namatay. Ang Region VI (Western Visayas) ang may pinakamataas sa bilang na 23,330, sinundan ng Region IV-A (CALABARZON) na may 16,515, Region IX (Zamboanga Peninsula) na umabot sa 12,317, Region X (Northern Mindanao) may 11,455 nagkasakit, at ang Region XII (SOCCSKSARGEN) na may 11,083 mga kaso.

Pagdidiin ni Duque, "Mahalagang ideklara ang national epidemic sa mga lugar na ito upang matukoy kung saan lugar ang dapat pagtuunan ng tulong, at upang magamit ng lokal na pamahalaan ang kanilang Quick Response Fund sa pagsagot sa naturang epidemiya.

Sa parte naman ni NDRRMC Tagapangulo Delfin Lorenzana, nagpalabas siya ng memoranda sa mga disaster response unit sa buong bansa para sa mahigpit na implementasyon ng deklarasyon ng national dengue epidemic.

Sa datos pa rin ng DOH, pito sa labimpitong (17) rehiyon ang naitalang lumampas na sa epidemic threshold ng dengue sa kanilang rehiyon sa nakaraang tatlong linggo. Kasama sa mga rehiyon na ito ay ang: Region IV-A (CALABARZON) na may 16,515 kaso; MIMAROPA – 4,254; V (Bicol) may 3,470; VI (Western Visayas) 23,330 kaso; VIII (Eastern Visayas) may 7,199; IX (Zamboanga Peninsula) may 12,317; X (Northern Mindanao) na may may 11,455 mga kaso.

Ang mga rehiyon naman n lumampas sa alert threshold level, ay ang Region I (Ilocos) na may 4,396 mga kaso; VII (Central Visayas) may 10,728; at BARMM (Bangsamoro Autonomous Region in Muslim Mindanao) na may 2,301 .

Ang kabuuang bilang sa buong bansa para lamang sa 29th Morbidity Week (Hulyo 14-20) ay 10,502. Ito ay 71% na mas mataas kumpara sa nakaraang taon sa parehong panahon na may 6,128 mga kaso.

Simula kahapon pagkatapos ng deklarasyon ng National Epidemic ay gagawin na ang Sabayang 4-O'clock Habit para Deng-Get Out, na pamumunuan ng Department of Health, kasama ang lahat ng ahensiya ng pamahalaan, mga eskuwelahan, mga tanggapan at mga komunidad na naglalayong puksain ang pinamumugaran ng mga lamok.

"Kaya sabaysabaytayong mag-search and destroy tuwing 4' o clock para deng-get-out!", paghihimok ni Duque sa publiko.

Dengvaxia and Medical wards to personally see the conditions of patients and assess the quality of service given to them. In a discussion cum press briefing that followed, he emphasized the importance of prevention of the occurrence of dengue as he encouraged all the local chief executives to make necessary actions in order to lessen and totally eradicate dengue cases nationwide.  
By virtue of Provincial Board Resolution No. 1246-2019, Cavite has been declared under state of calamity due to the dengue outbreak on July 16, 2019 to expedite the release of emergency funds. During Sec. Duque’s visit, 6th District Board Member and Chairperson on the Committee on Health, Nutrition and Population Kerby Salazar represented Governor Jonvic Remulla and Vice Governor Jolo Revilla.  
Other local government officials present were Cavite Councilor’s League President Benzen Raleigh Rusit, GMA Mayor Walter Echevaria, GMA Vice Mayor Maricel Torres, Maragondon Mayor Reynaldo Rillo, Indang Mayor Perfecto Fidel, General Emilio Aguinaldo Mayor Nelia Angeles, City of Bacoor Sangguniang Panlungsod Member Alde Pagulayan, Mayor’s League President Mayor Frederick Vida of the municipality of Mendez, Ternate Mayor Lamberto Bambao and Alfonso Mayor Randy Salamat who have committed to monitor the situation in their localities and immediately respond to dengue alerts.

Also, in attendance were Provincial Health Officer-in-Charge Dr. Romulo Lua, Dr. Nelson Soriano, and Dr. Aldous Angeles who explained the Cavite Provincial Emergency Response Plan for the Dengue Epidemic. Dr. Soriano tackled the actions taken to eradicate dengue and other vector-borne diseases in Cavite including the coordination and cooperation efforts with other government and private agencies for vector control activities on solid waste management, uninterrupted water supply, drainage management and behavioral change including health seeking behavior.

on early pregnancy, and understand its education, health, and development dimensions; understand the risks and contributory factors to early pregnancy; identify common ground and existing interventions; and formulate platforms or movement with diverse identities for stakeholders to continue policy advocacy and program implementation to address the concern. The participants of the event are youth, program implementers, and duty bearers.

Prior to the summit, DepEd and DOH, together with the steering committee, conducted a series of consultative meetings with faith-based organizations, civil society organizations (CSOs), youth groups, and key implementers, especially the students and parents, to be fully engaged and aware of the current dilemma.

The highlight of the summit will be the link of early pregnancy to education, health, and development. DepEd Secretary Leonor Magtolis Briones, DOH Secretary Francisco Duque III, and NEDA Secretary Ernesto Pernia will share their views, plans, and programs on the pressing concerns.

Other partner agencies and organizations are: National Youth Commission (NYC); Commission on Higher Education (CHED); Likhaan Center for Women’s Health; YPEER Pilipinas; Save the Children Philippines (SCP); United Nations International Children’s Fund (UNICEF); United States Agency for International Development (USAID); Reach Health Philippines; Volunteer Youth Leaders for Health (VYLH); and Center for Health Solutions and Innovations (CHSI).

tor Ninoy Aquino, was a turning point for him. He said this was when he started to become aware of the evils of martial law.  
"Huwag nating kalimutan ang napakamaraming mga kabalastugan na kinaharap natin noong martial law (We should never forget the many, many injustices we faced during martial law)," he said.

# RELIEF DISTRIBUTION IN CAVITE



Continuous rains brought by the southwest monsoon (habagat) and low pressure area (LPA) affected coastal communities and those living along rivers and creeks in the province of Cavite. In a prompt response, Governor Jonvic Remulla directed concerned offices, primarily the Provincial Social Welfare and Development Office (PSWDO) and the Provincial Disaster Risk Reduction and Management Office (PDRRMO) to assess the situation for the effective allocation of relief resources.

On August 5, 2019, Governor Remulla spearheaded the distribution of relief packs in Tanza and Trece Martires City with the team of volunteers from PSWDO and PDRRMO. The governor underscored that the program is intended to somehow help the families on their basic needs, since most of the livelihood are halted due to the bad weather condition. # DENR intensifies mangrove rehab efforts in Calabarzon

CALABARZON-- The regional office of the Department of Environment and Natural Resources (DENR) is encouraging local government units (LGUs) along the Calabarzon Region's coastlines to help sustain the mangrove rehabilitation program.

In an interview on Tuesday, Ann Hazel Javier of the DENR Calabarzon Regional Strategic Communication and Initiatives Section (RSCIS), underscored the need for collaborative undertakings on mangrove forest rehabilitation with the DENR and stakeholders in the area.

Javier cited as-

essment by Senior Science Research Specialist Violy Gulapo of the DENR Ecosystems Research and Development Bureau (ERDB), who disclosed that since 1918, the country's mangrove forest has been largely reduced.

Gulapo said their studies showed that "from a total number of 500,000 hectares of mangrove forest in 1918, this has drastically gone down to only 117,000 hectares in 1995" but these have gradually increased to 257,362 hectares in 2011.

She said that mangrove restoration may be attributed to coastal rehabilitation programs imple-

mented by the government, non-government organizations (NGOs), and the local communities.

Javier said that part of the activities on the mangrove rehabilitation program was the DENR Calabarzon Conservation and Development Division's massive mangrove tree planting at Barangay Talisay in Calatagan, Batangas.

She added the DENR regional office enjoined more than 60 volunteers from its Community Environment and Natural Resources Office (CENRO) in Calaca, Batangas, DENR-ERDB, village officials and villagers from Barangay

Talisay, and the Samahan ng Nagkakaisang Mangingisda sa Barangay Talisay (SNMBT) to sustain the mangrove rehabilitation program.

SNMBT is the fisherfolk's and people's organization in Calatagan which joined the mangrove propagule planting in observance of World Mangrove Day on July 26 this year at the town's coastal village.

SNMBT president Rodrigo de Jesus has expressed their full support to the rehabilitation program, as the group does regular mangrove planting activities since 2007.
