IMUS BFP PERSONNEL UNDERGO COVID-19 Mayor Emmanuel Maliks! TESTING; NEGATIVE RESULT

IMUS CITY, Cavite (PIA) -- The city government here recently conducted targeted testing for firefighters and personnel of the Imus Bureau of Fire Protection (BFP) pursuant to the provincial government's mandate for frontliners in the province to be subjected to corona virus disease (COVID)-19 checkup.

City Fire Marshal Clnsp. Rowena H. Gollod led the city's BFP personnel including fire aides during the testing conducted June 10 & 11, 2020 at the newly opened Imus Molecular Laboratory.

The results released Monday showed all the Imus BFP personnel that underwent COVID-19 testing are negative of the dreaded disease.

Meanwhile, according to the latest data recorded by the City Epidemiology and Surveillance Unit (CESU), the city has a total of 71 COVID-19 confirmed cases



The Philippine Drug Enforcement Agency (PDEA) is encouraging the citizenry to report illegal drug activities happening in their neighborhood through its 24/7 call and text hotlines and the Director General's own Facebook account.

"Known as **'Isumbong** Mo Kay Wilkins!', the Facebook page was created solely for informants and concerned citizens who want to help our country in its fight against illegal drugs," said PDEA Director General Wilkins M. Villanueva.

Besides providing a venue that is accessible to the public to report to PDEA drug-related activities believed to take place in communities, "Isumbong Mo Kay Wilkins!" also offers the fastest, secure and affordable means to receive information from concerned individuals.

"Supplied information may lead to the conduct of intelligence operations, and casing and surveillance operations, resulting in the arrest of high-value targeted personalities, seizure of sizeable amounts of illegal drugs, and dismantling of illegal drug facilities," Villanueva said.

The public may also send private messages of anti-drug information via Facebook page: Wilkins Villanueva.

"Rest assured that all received information will be treated with utmost confidentiality. Send reliable information and help us end the drug menace," the newly installed PDEA chief said, encouraging the public to be more involved in the national anti-drug campaign.

"Despite its new design, My.SSS retains the important features found in the old design. Members must not worry that it will take time to learn how to navigate the portal. The process of checking their contributions and membership records or making online transactions remains the same," Ignacio explained.

Ignacio said that members who registered at Mv.SSS can now once again access the web portal since the application and data correction for the Small Business Wage Subsidy (SBWS) program is already completed. For more than a month, the SSS website was solely dedicated to catering to the applications of qualified small business owners for the government's wage subsidy program.

Through My.SSS, members can process the following transactions:

"We are shifting our core and business processes to further improve our services to SSS members. In the coming months, other benefit claim applications such as the unemployment benefit will also be made available online as well as other programs like the Pension Loan Program (PLP). We are committing ourselves in fast-tracking the digital transformation of SSS in the coming years," Ignacio concluded.

and our people by the telling of our truth."

Andanar emphasized that the coronavirus pandemic has created a new world, but more than that, he said that it is the words used by the communicators that shaped this new environment.

"By these words, we create our nation," he said.

During the Webinar/Meeting, PCOO Assistant Secretary Ramon Cualoping III also discussed the strategies in communicating the new normal.

He said that more than the press releases, the communicators should also focus on changing the behavior of the people in the community into adapting the new normal.

"Our message is very simple – We heal, we recover, and we rise as one," he said.

Meanwhile, Dr. Eufemia Gamutin, schools

division superintendent of the Department of Education – Division of Davao de Oro, oriented the information officers on the new normal in the Philippine Education System.

She said that the new normal is basically shifting the traditional face-to-face learning instruction to distance learning, which include online learning, radio-based instruction, homeschooling, tv-based instruction, and modules/ebooks or mobile applications

The Deped division chief also disclosed that around 25,000 students from Kinder to Grade 12 were enrolled from June 1-5 or about 18 percent of last school year's student population of around 138,000.

She said that in their survey, some really chose to have a face-to-face modality, but she said that the said modality is the last recourse since there is still a threat of COVID-19 in the country. (PIA11, Michael Uy)

New normal calls for more rural development initiatives

QUEZON CITY, --"Investment in agriculture can
help revive food production
and create jobs following a crisis and enable rural communities to recover."

According to Agriculture Secretary William Dar, the government must continue to partner with the local government units and the private sectors, to increase food sufficiency levels, and modernize and industrialize the country's agri-fishery sector.

Emphasizing the role of agriculture in the recovery efforts of the Philippines' post-COVID-19, Dar called for the continuous support to the local farmers and fishers to enable the rural communities nationwide to adapt to the new normal.

During the kick-off meeting of the 10th World Bank Implementation Support Mission to the Philippine Rural Development Project (PRDP) on June 15, 2020, Dar emphasized the need to push for the development of an agriculture-driven economy and a country that is food-secure and resilient with prosperous farmers and fishers.

Following the transition to new normal, PRDP will align its regular menus including I-BUILD (Infrastructure Development Component) and I-REAP (Enterprise Development Component) subprojects with the Plant, Plant, Plant Program of the Department of Agriculture (DA).

As such, the project, which is now in its sixth year of implementation, will launch initiatives to address gaps in the food supply chains and logistics of various agri-fishery produce through the establishment and rehabilitation of rural infrastructure. PRDP will also focus on the provision of support services to jumpstart agribusiness enterprises.

According to PRDP National Program Director and DA Undersecretary Ariel Cayanan, the PRDP, aside from its usual menu of services under the I-PLAN, I-BUILD, and I-REAP components, will zoom in the development of short gestating projects through the proposed, 2nd Additional Financing for PRDP that aims to address gaps in the food supply chain and logistics and generate jobs in rural communities under the new normal.

Undersecretary
Cayanan highlighted in his
message the achievements of
the Project through the I-PLAN
Component which developed a
total of 119 value chain analysis
(VCA) on 66 commodities.

Also, all the country's 81 provinces have approved and updated their respective Provincial Commodity Investment Plans (PCIPs) which they leverage with other national government agencies and even the private sector.

To date, around P50 billion-worth of interventions are being funded to support various commodity value chains with PCIP as the main reference document.

Under the I-BUILD, it has constructed 813 kilometers of roads and established 468 linear meters of bridges reducing travel time by 31 percent and bringing down transportation cost by 25 percent in project areas. It has also provided 637 hectares of irrigation with more than 6,000 households benefitting from potable water systems.

More than 136,000 individuals were directly benefited by the 623 approved subprojects ranging from micro to small and medium enterprises under the I-REAP. With 59 more subprojects for approval within the month, additional 8,000 farmers and fishers are expected to participate in viable enterprises, consistent with Secretary Dar's directives to level-up agriculture and fisheries through modernization and industrialization.

To respond to the new challenges posed by the COVID-19 crisis, DA-PRDP will enhance its ICT capabilities by redesigning its capacity-building activities to take advantage of e-learning formats that are most appropriate to the ICT capacities of our stakeholders, partners, and beneficiaries. E-commerce platforms will be utilized for market linkages and online selling and buying of the products of the

enterprises being supported by the Project.

The 10th World Bank Implementation Support Mission will run from June 15 to July 3, 2020, to assess the project's progress towards achievement of the Project Development Objectives since the last Implementation Support Mission in November 2019.

Due to the crisis, DA-PRDP officials together with World Bank Task Team headed by Team Leader Mr. Eli Weiss will conduct a virtual site visit of 10 subprojects in 8 regions of the country instead of inspecting these physically. This is a first for the project to do the virtual subprojects' site visit utilizing the already mainstreamed Applied Geotagging Technology (AGT).

AGT has been developed by the PRDP's Geo-mapping and Governance Unit which has been adopted not only by DA and PRDP offices but also by local government offices, contractors, and national agencies that recognize the importance of the tool to avoid investment duplication.

Also, the World Bank has previously recognized the system as a critical tool in the promotion of transparency and anti-corruption, naming the Philippines as the leading nation in utilizing AGT. SOURCE:### (PRDP NPCO InfoAce)

DON'T BLAME RAPE VICTIMS, SAYS NUN

A Catholic nun has joined calls for change of attitudes towards sexual assaults on women.

Benedictine Sr. Mary John Mananzan challenged the view that female rape victims are responsible for being assaulted.

"Don't blame the victim," Sr. Mananzan said.

The nun made the statement after a police station in Lucban town in Quezon province told women not to wear skimpy clothes in order not to be victimized.

The police hierarchy has ordered an investigation into the June 11 Facebook post, which has since been deleted.

But Sr. Mananzan countered victim-blaming, adding that some rape victims are even elderly and simple women.

"The blame is totally on the rapist, the predator," she said./ source: cbcp
