Fr. Arturo Joseph Monzon Balagat led the event to give recognition to all the concerned government agencies and partakers who gave their support for the success of the program.





CALAX operations to start a yearearly with funding secured

Province of Cavite had closed the P24.2-billion (PIA) – The Cavite-Laguna Expressway (CALAX) project is seen to start commercial operations of some segments in the Laguna side as early as July 2019 with the funding for the construction and concession secured by a loan.

Pacific Metro Tollways Corp. (MPTC) Chief Financial Officer Christopher Daniel C. Lizo

loan with six banks namely: BDO Unibank, Inc.; Union Bank of the Philippines, Inc.; Rizal Commercial Banking Corp. (RCBC); Bank of the Philippine Islands (BPI); Security Bank Corp., and Land Bank of the Philippines.

The loan is intended to finish the P35.43billion (45.29-kilometer) CALAX project, funding the disclosed that the company Laguna and Cavite seg-

The first 10 kilometers of CALAX on the Laguna side is scheduled to open in July, a year earlier from schedule while the entrance from the Cavite side might be delayed since substantial right of way from the Department of Public Works and Highways (DPWH) is not yet given.

"Some sections ahead, some sections delayed. We're opening Sections 6 to 8, which is from Mamplasan to Sta. Rosa, July. So that's ahead of schedule... Cavite, admittedly delayed. Kulang pa 'yung right of way [Right of way is still lacking]," explained Mr. Lizo.

Meanwhile, MPCALA Holdings President and General Manager Roberto V. Bontia revealed that the Cavite side is targeted to start construction by first quarter next year.

"They will start hopefully first quarter of next year," he said.

CALAX is targeted to open by July 2020 which will connect the Manila-Cavite Expressway (CAVITEx) to the South Luzon Expressway (SLEx) giving much convenience to commuters with reduced travel time from the two points by half from one hour and 30 minutes to forty five minutes. National News Manila Bay rehab kicks off January 27



DENR Secretary Roy Cimatu

The government is all set to start the Manila Bay rehabilitation on January 27.

The kick off activity which will be spearheaded by the Department of Environment and Natural Resources (DENR) will also include the unveiling of the Manila Bay Rehabilitation Plan.

According **DENR Secretary Roy** Cimatu, the rehabilitation project requires a coordinated and integrated effort of all stakeholders to clean-up all water bodies draining into the bay and deal with the sources of pollution.

"All of these efforts for the clean-up are integrated. We plan to

clean the Manila Bay including all the esteros and rivers connected—the Pasig River and the Laguna Lake," Cimatu said.

Cimatu said the task of bringing back the historic bay to its former glory would not be totally impossible if all stakeholdDENR personnel will be "at the front row" to achieve the goal of making the coastal waters of Manila Bay fit for swimming again.

Cimatu said the **DENR** regional offices in Metro Manila and the ...page 3

"This mission is ossible. This mission calls for dedication and hardwork from all those who will help us in this operation," Cimatu

"I hope and I pray that something good will come out of the BOL. Though the plebiscite is forthcoming, we have every reason to believe that it would pass the people's will at sana magkaroon tayo ng kapayapaan because if not mahirapan tayo nito." Duterte said.

According to Pres. Duterte, the presidency was a gift from God and, in turn, he will do his job conscientiously with the fight against drugs topping his agenda. He, however, admitted the gravity of the problem is overwhelming, saying "I could not really fulfill my promise to do away with drugs within six years. Impossible... It's going to be a continuing one."

The president even made a stern warning that in the remaining three years of his term, his administration will be targeting 'big time' people involved in illegal drugs.

Duterte's war on drugs has been continuously subjected to various criticisms from the religious and civil society groups but the President maintains the effects of drugs have wreaked havoc to families, making some of them dysfunctional, and to the community, in general with crimes such as robbery, rape, and murder.

After his speech, President Duterte willingly obliged for photo ops, first with the Tolentino clan, then with the local government officials of CALABARZON. He was later serenaded with Tagalog songs by singer Faith Cuneta. (Ruel Francisco, PIA-Cavite)

Calabarzon region, as well as its provincial offices in Pampanga and Bataan, will also be involved in the rehabilitation efforts.

He also underscored the need to "clean the water source, so as to put an end to pollution."

"We need to find out where the outfalls come from individually, because in just one estero we can find lots of outfalls," Cimatu pointed out.

A list of local establishments that violated environmental laws will be released on Jan. 27, Cimatu revealed.

Although Manila Bay is still known for having one of the most beautiful sunsets, its waters are considered the most polluted in the country due to domestic sewage, toxic industrial effluents from factories and shipping operations, and leachate from garbage dumps, among others.

Cimatu said the waters along the Roxas Boulevard, which has the best view of the sunset, is even "worse than Boracay."

"We have seen the problem closely this time, and we have already laid out a detailed solution," he added.

The DENR's goal, he said, is to bring down the coliform level in all esteros to 100 most probable number (MPN) per 100 milliliters (mL).

Cimatu shared that reforestation of mangrove areas in the Las Piñas-Parañaque Critical Habitat and Ecotourism Area or LPPCHEA is also included in the rehabilitation plan.

The DENR chief also bared that Malacañang has approved a budget amounting to P42.95 billion for three years. This amount will cover cleanup of priority waterways, relocation of informal settler families (ISFs), and implementation of temporary sanitation facilities in ISF communities prior to relocation.
