Maynilad: 16-day water interruption in MuntiParLas

Water Mavnilad has notified several barangays in Las Piñas, Muntinlupa, Parañague, Pasay and Imus regarding daily water interruption for 16 davs

Maynilad said this is still due to the on going facility maintenance at the Putatan Water Treatment Plants.

According to Maynilad, they are reportedly cleaning the filter at the plant due to the entry of cloudy water.

The water delay began on April 1 and is expected to last until April 16

Maynilad assured that mobile water tankers will continue to circulate to deliver pota-

ble water to the affected areas. It is said that they also placed stationary water tanks in various areas belonging to the affected.

Normal operations will return once the cleaning of the filters in their plant is completed,

Additional P1K social pension fund for poor seniors ok'd

MANILA, (PIA) -- Senior Citizens Partylist Representative Rodolfo "Ompong" Ordanes has announced the approval of the P1,000 additional social pension fund for 4 million indigent senior citizens in the country.

This is also based on the confirmation made earlier by Social Welfare Secretary Rex Gatchalian, who said that the additional P25.6 billion needed to double the pension amount will be drawn from the department's "unprogrammed funds."

The partylist solon welcomed the development and said that their efforts to ensure that the additional pension was funded have been realized.

For now. Ordanes said that Gatchalian is just waiting for the implementing rules and regulations (IRR) to come from the National Commission of Senior Citizens (NCSC).
