Year 1898 when the Filipino revolutionaries defeated the Spanish soldiers in the Battle of Alapan in the province of Cavite. As a sign of victory, the National Flag was waved for the first time after the battle. It became an inspiration for the successive victories of the Filipino soldiers in neighboring areas during the uprising, until the Philippines finally gained independence on June 12 that year.

May 28 was declared on March 6, 1965 as National Flag Day or National Flag Day (Proclamation No. 374, s. 1965), as a reminder of the heroism of those who fought for the nation, and to recognize our National Flag as a symbol of freedom and independence.



Army reserve units play key roles in rescue, relief efforts

MANILA – Reserve units of the Philippine Army (PA) play a key role in disaster response, Army chief Lt. Gen. Romeo Brawner Jr. said during his visit to the Reserve Command Philippine Army (RCPA) headquarters in Camp Riego De Dios in Tanza, Cavite on Friday.

"The **CGPA** (Commanding General of the Philippine Army) lauded Army reservists for playing a crucial role in the relief and rescue efforts that saved lives in the aftermath of calamities, particularly in the aftermath of Typhoon Odette late last year and Tropical Storm Agaton last month," PA spokesperson Col. Xerxes Trinidad said in a statement Saturday.

During the visit, Brawner assured more support for the RCPA headquarters and its line units, which include the Regional Community Defense Groups and Community Defense Centers.

He also underscored the Army leadership's support for the RCPA in terms of personnel, logistics, fuel requirements, and facilities improvement.

Brawner also highlighted the need to strengthen the country's

reserve force to bolster the country's defense readiness posture.

He reiterated Armed Forces of the Philippines (AFP) Chief, Gen. Andres C. Centino's directive to tap reservists for civil-military operations, such as bloodletting and tree-planting activities.

"Let's remain solid as the Philippine Army. Let us continue to be professionals. Let's continue to fulfill our mandate with utmost commitment," Brawner said.

The PA has about 790,000 standby and ready reserves who perform an important role in the implementation of development support and security operations of the AFP, especially in humanitarian assistance and disaster response efforts.

As this developed, Trinidad said the 546th Engineer Combat Battalion (546ECB) of the 53rd Engineer Brigade continues to build temporary homes for families displaced by "Agaton" in Baybay City, Leyte.

The shelters, funded by the Office of the Civil Defense 8 (Eastern Visayas), are being built by Army engineers in cooperation with the Department of
