Marcos' housing program gets support from urban po

The "Pambansang Pabahay for the Pilipino Housing" (4PH) Program of President Ferdinand R. Marcos Jr. has garnered support from the urban poor.

This is after the Urban Poor Action Committee (UPAC) met with key officials of the Department of Human Settlements and Urban Development (DHSUD) led by DHSUD Secretary Jose Rizalino Acuzar to discuss the housing issue and some recommendations for 4PH.

Madeline Suarez of UPAC said that she hopes that their "People's Plan" will be

endorsed under the national housing program.

"It is good to consider this (urban poor group's shelter initiatives) as part of the realization of the 4PH implemented by the government. We want to emphasize that we support 4PH, and in support we want to be part of the process that will take place," said Suarez.

It is likewise imperative that applicants have not been convicted by final judgment of an offense or crime involving moral turpitude, or disgraceful or immoral conduct, dishonesty, examination irregularity, drunkenness, or addiction to drugs. Furthermore, they must not have been dishonorably discharged from military service, or dismissed for cause from any civilian position in the government.

Moreover, applicants should not have taken the same level of Career Service Examination, either through PPT or CSC Computer-
