"We believe expanding our public information campaign nationwide is crucial to helping Filipinos in remote areas." he added.

Highlighting PIA's extensive network as vital for Konsulta's accessibility, Ledesma announced upcoming program improvements.

"The current list of 21 free medicines will soon expand to 53 under PhilHealth's Guaranteed and Accessible Medications for Outpatient Treatment (GAMOT) program. Additionally, ultrasound and mammograms will be included for early breast cancer detection in women," he concluded. (PIA-

DOJ vows to earnestly pursue terror financiers

MANILA – Justice Secretary Jesus Crispin Remulla on Monday assured his office will earnestly pursue the criminal charges against financers of local terrorism following the filing of charges against a local firm for violation of Republic Act (R.A.) No. 10168, or the Terrorism Financing Prevention and Suppression Act of 2012). "We will never

stop running after terrorists who continue to sow fear among our communities, you have no place in our society," Remulla said in a statement.

The Department of Justice (DOJ) Task Force on Counter-Terrorism and Terrorism Financing led by Senior Deputy State Prosecutor Peter Ong has filed criminal charges before the Cebu Regional Trial Court Branch 74 against Community Empower-

ment Resource Network, Inc. (CERNET) and its Council, members of its board of trustees and officers, for violation of Section 8(ii), in relation to Section 9 of RA 10168.

According to the complaint filed by the Joint Task Group Cebu, CERNET, through its finance and administrative officer, allegedly gave a former CERNET employee PHP135,000.00

sometime in September 2012, to be delivered in Dumaguete City for the logistical support (food provision, armaments, ammunitions, firearms, medical supplies and other operational requirements) of the South Eastern Front (SEF) of the New People's Army (NPA).

"After a judicious evaluation of the evidence at hand, the Task Force found probable cause against the respondents as charged. CERNET'S act of giving PHP 135,000 cash to the NPA South Eastern Front is undeniably an act of making available funds to a designated terrorist organization, hence, punishable under Section 8(ii) of R.A. No. 10168,"

Filipino children's choir, Young Voices of the Philippines (YVP), will participate and sing at the first World Children's Day called for by Pope Francis in Rome next week.

Around 70,000 children from at least 101 nations are expected to fill Rome's Olympic Stadium for the opening events on May 25 and attend Mass with the pope in St. Peter's Square the next morning.

YVP conductor Dr. Maria Theresa Vizconde-Roldan said the YVP will be singing along with other children's choirs at the stadium and during the papal Mass.
